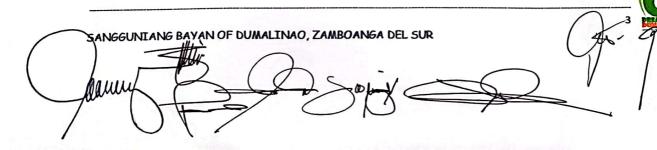

**SECTION IV. SEPARABILITY CLAUSE.** If any part or provision of this Ordinance is declared unconstitutional or invalid, the same shall not affect the validity and effectivity of the other parts or provisions hereof.

**SECTION V. EFFECTIVITY.** This Ordinance shall take effect immediately upon review and approval.

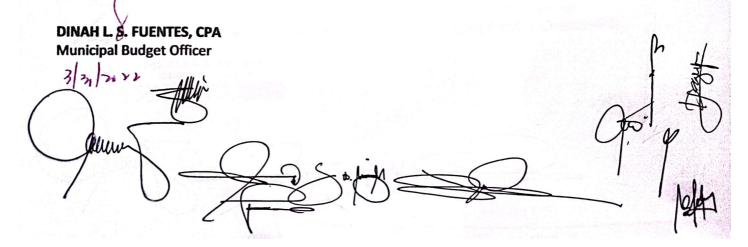

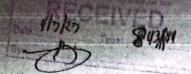

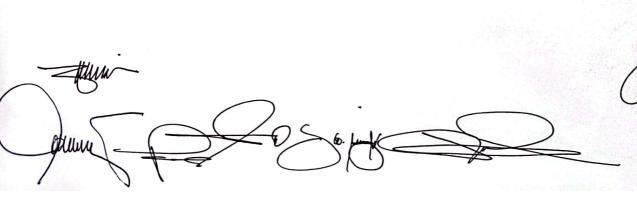
