AN ORDINANCE APPROPRIATING THE AMOUNT OF TWO MILLION ONE HUNDRED NINETY-SEVEN THOUSAND PESOS (PHP2, 197, 000.00) TAKEN FROM THE UNAPPROPRIATED SAVINGS OF SUPPLEMENTAL BUDGET NO. 1 FY 2024 OF APPROPRIATION ORDINANCE NO. 2024-05-508 DATED MAY 2, 2024 TO COVER THE SALARIES AND WAGES UNDER GENERAL SERVICES OF THE OFFICE OF THE MUNICIPAL MAYOR FOR CONTRACTUAL AND JOB-ORDER EMPLOYEES OF THE DIFFERENT OFFICES OF THE LOCAL GOVERNMENT UNIT OF DUMALINAO, ZAMBOANGA DEL SUR, OTHERWISE KNOWN AS SUPPLEMENTAL BUDGET NO. 2 FOR FISCAL YEAR 2024.
