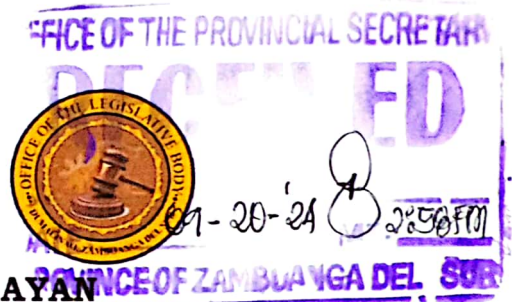

MUNICIPAL ORDINANCE NO. 2024-09-511

AN ORDINANCE ADOPTING THE PHILHEALTH KONSULTASYONG SULIT AT TAMA "PHILHEALTH KONSULTA" PACKAGE PURSUANT TO REPUBLIC ACT NO. 11223 AND PROVIDING SPECIFIC GUIDELINES FOR THE DISPOSITION AND ALLOCATION OF THE CAPITATION FOR HEALTH AND NON-HEALTHCARE PROVIDER IN THE MUNICIPALITY OF DUMALINAO, PROVINCE OF ZAMBOANGA DEL SUR.

WHEREAS, the Republic Act No. 11223, otherwise known as the "Universal Health Care (UHC) Act," mandates the adoption of a comprehensive health care system, ensuring equitable access to quality and affordable health care services for all Filipinos;

WHEREAS, the Philippine Health Insurance Corporation (PhilHealth) has developed the Konsultasyong Sulit at Tama (PhilHealth Konsulta) package as part of its primary care benefits to promote preventive health care services, early detection of diseases, and continuous management of health conditions;

WHEREAS, the Local Government Unit (LGU) of Dumalinao recognizes the importance of integrating the PhilHealth Konsulta Package into its health care programs to improve the health and well-being of its constituents;

WHEREAS, there is a need to establish specific guidelines for the disposition and allocation of the capitation payments provided under the PhilHealth Konsulta Package to ensure that these funds are used effectively and efficiently;

NOW THEREFORE, on motion by **HON. JELITO R. PEÑONAL** and duly seconded by **HON. MA. GEMMA C. ALBISO**;

BE IT ORDAINED by the 12th Sangguniang Bayan of Dumalinao in session duly assembled that:

SECTION I. TITLE. This Ordinance shall be known as the “Philhealth Konsulta Ordinance.”

SECTION II. DECLARATION OF POLICY. It is the policy of the Municipality of Dumalinao to ensure that all residents have equitable access to quality health care services by adopting the PhilHealth Konsulta Package, in line with the provisions of Republic Act No. 11223.

SECTION III. OBJECTIVES. The LGU-Dumalinao aims to adopt and implement the PhilHealth Konsulta Package in the municipality, in line with the provisions of Republic Act No. 11223 and to provide specific guidelines for the disposition and allocation of the capitation payments received under the PhilHealth Konsulta Package.

SECTION IV. ADOPTION OF THE PHILHEALTH KONSULTA PACKAGE. The Local Government Unit of Dumalinao hereby adopts the PhilHealth Konsulta Package as part of its primary health care program. All eligible residents shall be entitled to the benefits under this package, including preventive, promotive, curative, and rehabilitative health services. All health care facilities and providers under the jurisdiction of the LGU shall participate in the PhilHealth Konsulta Program and comply with the guidelines set forth by PhilHealth.

SECTION V. GUIDELINES FOR THE DISPOSITION AND ALLOCATION OF CAPITATION PAYMENTS. The following guidelines shall govern the disposition and allocation of capitation payments received under the PhilHealth Konsulta Package:

a. **CAPITATION FUND MANAGEMENT** - all capitation payments received from PhilHealth shall be managed by the Municipal Health Office (MHO) in coordination with the Municipal Treasurer's Office (MTO). A separate account shall be maintained for this purpose, and the funds shall be used exclusively for health-related expenditures in accordance with the guidelines provided by PhilHealth.

b. **ALLOCATION OF FUNDS** - the capitation payments shall be allocated as follows:

1. 50% for the enhancement and maintenance of health care facilities, including the procurement of medical supplies, equipment, and reagents, medicines and ambulance maintenance.

2. 15% for the remuneration of health care providers, including medical technologist, nurses, midwives, allied health professionals and other health personnel involved in the delivery of the PhilHealth Konsulta services.

3. 10% for the physicians and Doctors to the Barrio (DDTB) and DOH augmented physicians and volunteers.

4. 25% for the remuneration of non-health care providers, such as Accredited Barangay Health Workers (BHW) and community health volunteers.

c. **TRANSPARENCY AND ACCOUNTABILITY** - the MHO, in coordination with the MTO, shall submit a quarterly report to the Office of the Municipal Mayor detailing the receipt and utilization of the capitation payments. This report shall be made available to the public to ensure transparency and accountability.


SECTION VI. ROLES AND RESPONSIBILITIES OF CONCERNED OFFICES AND PERSONNEL. The following roles and responsibilities are hereby assigned:

a. The MHO shall oversee the implementation of the PhilHealth Konsulta Package, manage the capitation funds, and ensure compliance with the guidelines set forth in this Ordinance.

b. The MTO shall assist the MHO in the management of the capitation funds, including the maintenance of a separate account and the preparation of financial reports.

c. BHWs shall assist in the dissemination of information about the PhilHealth Konsulta Package and encourage residents to register and avail of the services offered.

d. The Sangguniang Bayan shall provide oversight in the implementation of this Ordinance, including the review of quarterly reports and the conduct of hearings or investigations as necessary.

SECTION VII. PENALTIES. Non-compliance with the provisions of this Ordinance and PhilHealth Circular, terms and conditions of the Performance Commitment and all existing related laws and policies shall be dealt with accordingly.


SECTION VIII. SEPARABILITY CLAUSE. If any provision of this Ordinance is declared unconstitutional or invalid, the other provisions not affected thereby shall remain in full force and effect.

SECTION IX. REPEALING CLAUSE. All ordinances, resolutions, executive orders, and other issuances inconsistent with this Ordinance are hereby repealed or modified accordingly.


SECTION X. EFFECTIVITY. This Ordinance shall take effect upon review and approval.
