

## **RESOLUTION NO. 0392-2024**

RECOMMENDING TO THE MUNICIPAL DEVELOPMENT COUNCIL (MDC) OF THE LOCAL GOVERNMENT UNIT OF DUMALINAO TO REDUCE AND DISTRIBUTE THE BUDGET ALLOCATION OF THE CONSTRUCTION OF DUMALINAO ETERNAL GARDEN AT ANONANG, DUMALINAO, ZAMBOANGA DEL SUR, PHASE-1, AND COMPREHENSIVE LIVELIHOOD TRAINING FOR FARMERS, FISHERFOLKS, AND WOMEN'S WITH INPUTS IN THE APPROVED MDC RESOLUTION NO. 5 SERIES OF 2024, TO BE ALLOCATED IN VARIOUS PROGRAMS, PROJECTS, AND ACTIVITIES OF THE MUNICIPAL GOVERNMENT FOR CALENDAR YEAR 2025.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Rholly A. Labang to recommend to the Municipal Development Council of LGU-Dumalinao to reduce and distribute the budget allocation of the Construction of Dumalinao Eternal Garden at Anonang, Dumalinao, Zamboanga del Sur, Phase-1, and Comprehensive Livelihood Training for Farmers, Fisherfolks, and Women's with Inputs in the approved MDC Resolution No. 5 Series of 2024, to be allocated in various programs, projects, and activities of the Municipal Government for Calendar Year 2025;

WHEREAS, Section 447, (a), (5) of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that the sangguniang bayan as the legislative body of the municipality, shall pass resolutions to ensure the efficient and effective delivery of the basic services and facilities as provided under Section 17 of this Code;





WHEREAS, the approved MDC Resolution No. 5 Series of 2024 of the 20% Economic Development Fund for Calendar Year 2025 amounting to Thirty-Six Million Seven Hundred Thirty-Four Thousand Nine Hundred Three Pesos and Twenty Centavos (Php36, 734, 903.20), which was allocated to different projects. programs, and activities;

WHEREAS, the Construction of Dumalinao Eternal Garden at Anonang, Dumalinao, Zamboanga del Sur, Phase-1 amounting to Fifteen Million Pesos (Php15, 000, 000.00) and Comprehensive Livelihood Training for Farmers. Fisherfolks, and Women with Inputs for Five Million Pesos (Php5, 000, 000.00) in the approved 20% EDF for CY 2025, which were hugely allocated therein:

WHEREAS, while it is true that the project mentioned above is beneficial to the people, it is seemingly not in accord with the promotion of the General Welfare as enshrined under Section 16 of the Republic Act No. 7160;

WHEREAS, it is a well-settled rule that development projects must have equal opportunities and benefits to the general constituencies; thus, rational use of resources has comprehensive benefits and ample opportunities;

WHEREAS, some other barangays and residents there also clamor for a somehow decent and convenient eternal place to settle their loved ones and relatives:

WHEREAS, the August body recommended to the MDC that the budget allocation for the Construction of Dumalinao Eternal Garden at Anonang, Dumalinao, Zamboanga del Sur, Phase-1, be distributed for the rehabilitation of the existing Public Cemetery at:

Php1, 500, 000.00; 1. Bibilik Cemetery Php2, 000, 000.00; 2. Rebokon Cemetery

3. Pantad-Baga Cemetery Php2, 500, 000.00;

Php1, 500, 000.00; 4. Cuatro-Cuatro Cemetery

5. Tina Cemetery Php1, 500, 000.00;

6. Malasik Cemetery Php1, 500, 000.00;

7. Pinig-libano Cemetery Php1, 500, 000.00; and

8. Dumalinao Eternal Garden -Php3, 000, 000.00.

WHEREAS, the August body also recommended to the MDC that the budget allocation for the Comprehensive Livelihood Training for Farmers, Fisherfolks, and Women with Inputs be distributed for the seminars and training:

1. DepEd-QualCi Meet Php500, 000.00;

2. Banana Planting Php500, 000.00;

3. Lower Sta. Cruz, Road Concreting - Php1, 500, 000.00;

4. Extension for Motor Pool Php500, 000.00;

5. Seminars/Trainings Php1, 000, 000.00; and

6. Procurement of Traffic Vehicle -Php1, 000, 000.00.

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. HERMES B. CABALES, the body resolved, as it hereby resolves to recommend to the Municipal Development Council of Local Government Unit of Dumalinao to reduce and distribute the budget allocation of the Construction of Dumalinao Eternal Garden at Anonang, Dumalinao, Zamboanga del Sur, Phase-1, and Comprehensive Livelihood Training for Farmers, Fisherfolks, and Women's with Inputs in the approved MDC Resolution No. 5 Series of 2024, to be allocated in various programs, projects, and activities of the Municipal Government for Calendar Year 2025.
