### RESOLUTION NO. 0400-2024

ADOPTING THE APPROVED MDC RESOLUTION NO. 1, 2, 3, AND 4 SERIES OF 2024 OF THE MUNICIPAL DEVELOPMENT COUNCIL OF THE LOCAL GOVERNMENT UNIT OF DUMALINAO, PROVINCE OF ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action are the approved MDC Resolution Nos. 1, 2, 3, and 4 Series of 2024 of the Municipal Development Council of the locality;

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise powers expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, the Municipal Development Council (MDC) of the Local Government Unit of Dumalinao, Zamboanga del Sur, convened and deliberated on various developmental plans and initiatives;

WHEREAS, the MDC has approved Resolution No. 1, Resolution No. 2, Resolution No. 3, and Resolution No. 4, all series of 2024, which are aimed at enhancing local development, improving public services, and fostering community participation;





WHEREAS, the August body finds that the adoption of these resolutions is essential to ensure the timely implementation of the proposed projects and initiatives benefitting the constituents of Dumalinao;

BALANDRA, and severally seconded by the August body, it was resolved, as it is hereby resolved, to adopt the approved MDC Resolution Nos. 1, 2, 3, and 4 Series of 2024 of the Municipal Development Council of the Local Government Unit of Dumalinao, Province of Zamboanga del Sur.
