

## **RESOLUTION NO. 0403-2024**

ADOPTING THE APPROVED 20% ECONOMIC DEVELOPMENT FUND (EDF) FOR CALENDAR YEAR 2025 AMOUNTING TO THIRTY-SIX MILLION SEVEN HUNDRED THIRTY-FOUR THOUSAND NINE HUNDRED THREE PESOS AND TWENTY CENTAVOS (PHP36, 734, 903.20) OF MDC RESOLUTION NO. 5 SERIES OF 2024 OF THE MUNICIPAL DEVELOPMENT COUNCIL OF THE LOCAL GOVERNMENT UNIT OF DUMALINAO, PROVINCE OF ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the approved 20% EDF for CY 2025 amounting to Php36, 734, 903.20 of MDC Resolution No. 5 Series of 2024 of the LGU-Dumalinao;

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise powers expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, the 20% EDF for CY 2025 was the product of careful discussion and deliberations of the members of the Municipal Development Council (MDC) as part of the Annual Investment Plan for in the locality, aligning to the National Government Agenda;

WHEREAS, the said fund allocation aims to support and finance various developmental programs, projects, and activities that promote economic growth,



improve public services, and enhance the quality of life of the constituents of Dumalinao;

WHEREAS, the August body recognizes the importance of ensuring that the approved allocation of the 20% EDF for CY 2025 aligns with the priority needs and objectives of the LGU-Dumalinao;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

**NOW THEREFORE,** premises above-considered, on motion by **HON. FREDERICK R. BALANDRA**, duly seconded by **HON. ROMEO G. LIGAN**, it was resolved, as it is hereby resolved, to adopt the approved 20% Economic Development Fund (EDF) for Calendar Year 2025 amounting to Thirty-Six Million Seven Hundred Thirty-Four Thousand Nine Hundred Three Pesos and Twenty Centavos (Php36, 734, 903.20) of MDC Resolution No. 5 Series of 2024 of the Municipal Development Council of the Local Government Unit of Dumalinao, Province of Zamboanga del Sur.
