**FAVORABLY REQUESTING THE LOCAL CHIEF EXECUTIVE, HONORABLE  
MAYOR JUNAFLO R. CERILLES, RMT, MAGD, TO PROVIDE FREE  
MEDICAL CHECK-UPS TO SENIOR CITIZENS, PERSONS WITH DISABILITY,  
AND PREGNANT WOMAN IN THE RURAL HEALTH UNIT OF THE  
MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.**

**WHEREAS,** presented for consideration and appropriate action is the proposed resolution of Hon. Jelito R. Peñonal to favorably request the Local Chief Executive to provide free medical check-ups to Senior Citizens, PWD, and pregnant women in the RHU-Dumalinao;

**WHEREAS,** Section 447, (a), (5) of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that the sangguniang bayan as the legislative body of the municipality, shall pass resolutions to ensure the efficient and effective delivery of the basic services and facilities as provided under Section 17 of this Code;

**WHEREAS,** the Municipality of Dumalinao is committed to upholding the welfare, health, and quality of life of its residents, particularly those who are most vulnerable, such as senior citizens, persons with disabilities (PWDs), and pregnant women;

**WHEREAS**, regular medical check-ups are essential in promoting preventive health care, early diagnosis, and timely medical interventions that can significantly improve the health and well-being of these specific groups within the community;

**WHEREAS**, many senior citizens, PWDs, and pregnant women face financial constraints and other barriers to accessing regular health services, making it imperative for the local government to support their health needs;

**WHEREAS**, providing free medical check-ups in the Rural Health Unit will ensure that these vulnerable groups have access to essential health services and will align with the government's objective to deliver quality health care for all;

**WHEREAS**, the provision of such medical services will not only enhance the well-being of these residents but will also contribute to a healthier, more resilient community;

**WHEREAS**, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

**NOW, THEREFORE**, premises above-considered, on motion by **HON. JELITO R. PEÑONAL**, the body resolved, as it hereby resolves to favorably request the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD, to provide free medical check-ups to Senior Citizens (SC), Persons With Disabilities (PWD), and pregnant women within the Rural Health Unit of the Municipality of Dumalinao, Zamboanga del Sur.
