**RESOLUTION NO. 0394-2024**

**ADOPTING THE PROVINCIAL ORDINANCE NO. 013-2019, ENTITLED “IMPLEMENTING ZERO OPEN DEFECATION (ZOD) POLICY IN THE PROVINCE OF ZAMBOANGA DEL SUR, IMPOSING FINES AND PENALTIES FOR UNLAWFUL AND PROHIBITED ACTS AND PROVIDING FUNDS THEREOF” IN CONFORMITY TO DEPARTMENT OF HEALTH ADMINISTRATIVE ORDER NO. 2019-0054, GUIDELINES ON THE IMPLEMENTATION OF THE PHILIPPINE APPROACH TO SUSTAINABLE SANITATION (PHATSS) IN THE MUNICIPALITY OF DUMALINAO, PROVINCE OF ZAMBOANGA DEL SUR.**

**WHEREAS**, presented for consideration and appropriate action is the endorsement of the Municipal Sanitation Inspector to adopt the Provincial Ordinance No. 013-2019 of the Sangguniang Panlalawigan of Zamboanga del Sur, in conformity to DOH AO No. 2019-0054;

**WHEREAS**, Section 447, (a), (5) of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that the sangguniang bayan as the legislative body of the municipality, shall pass resolutions to ensure the efficient and effective delivery of the basic services and facilities as provided under Section 17 of this Code;

**WHEREAS**, the Provincial Government of Zamboanga del Sur enacted Provincial Ordinance No. 013-2019, which mandates the implementation of the Zero Open Defecation (ZOD) policy throughout the province to address public health, environmental sanitation, and hygiene concerns;



**WHEREAS**, the Department of Health (DOH) Administrative Order No. 2019-0054 provides the Philippine Approach to Sustainable Sanitation (PhATSS), which outlines guidelines to support the Zero Open Defecation (ZOD) Policy and aims to end open defecation practices by ensuring safe, sustainable sanitation in all barangays nationwide;

**WHEREAS**, the Municipality of Dumalinao is committed to advancing public health and environmental sustainability, aligning with the provincial ZOD policy to improve community hygiene and reduce sanitation-related diseases;

**WHEREAS**, it is deemed essential for the Municipality of Dumalinao to adopt the Provincial Ordinance and enforce ZOD measures, including the imposition of appropriate penalties for non-compliance, as well as allocation of funds to support program implementation and public awareness campaigns;


**WHEREAS**, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

**NOW, THEREFORE**, premises above-considered, on motion by **HON. JELITO R. PEÑONAL**, the body resolved, as it hereby resolves to adopt the Provincial Ordinance No. 013-2019, "*Implementing Zero Open Defecation (ZOD) Policy in the Province of Zamboanga del Sur, Imposing Fines and Penalties for Unlawful and Prohibited Acts and Providing Funds Thereof*" in conformity with Department of Health Administrative Order No. 2019-0054, guidelines on the implementation of the Philippine Approach To Sustainable Sanitation (PHATSS) in the Municipality of Dumalinao, Province of Zamboanga del Sur.

**LET** the copy of this resolution be furnished to concern offices and/or officials for reference, guidance, and appropriate action.


