RESOLUTION NO. 0395-2024

FAVORABLY REQUESTING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLOR S. CERILLES, RMT, MAGD, TO EXEMPT THE STUDENTS OF THE DEPARTMENT OF EDUCATION (DEPED)-DUMALINAO FROM PAYING MEDICAL FEES AT THE RURAL HEALTH UNIT OF DUMALINAO THAT WHO WILL PARTICIPATE IN VARIOUS SCHOOL ACTIVITIES SUCH AS ATHLETIC MEET, JOURNALISM, IMMERSION PROGRAMS, SCOUTING, AND OTHER RELATED SCHOOL ACTIVITIES.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Rholly A. Labang to favorably request the Local Chief Executive to exempt the students of the Department of Education (DepEd)-Dumalinao from paying medical fees at the RHU Dumalinao that who will participate in various school activities such as athletic meet, journalism, immersion programs, scouting, and other related school activities;

WHEREAS, Section 447, (a), (5) of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that the sangguniang bayan as the legislative body of the municipality, shall pass resolutions to ensure the efficient and effective delivery of the basic services and facilities as provided under Section 17 of this Code;

WHEREAS, the Department of Education (DepEd)-Dumalinao, in its mission to foster the holistic development of students, encourages participation in various

co-curricular and extracurricular activities such as athletic meets, journalism programs, immersion activities, scouting, and other school-related programs;

WHEREAS, participation in these activities often requires medical assessments, clearances, and other health-related certifications provided by the Rural Health Unit (RHU) of Dumalinao, which may pose an additional financial burden to students and their families, particularly those from low-income households;

WHEREAS, waiving the medical fees for students participating in these activities would promote inclusivity, enabling more students to participate in programs that enhance their physical, mental, and social well-being;

WHEREAS, the LGU-Dumalinao has always supported the educational and personal development of its youth, recognizing that well-rounded students contribute positively to the community and the future of the municipality;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. RHOLLY A. LABANG**, the body resolved, as it hereby resolves to favorably request the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD, to exempt the participating students of the Department of Education (DepEd)-Dumalinao from paying medical fees at the Rural Health Unit of Dumalinao that who will participate in various school activities such as athletic meet, journalism, immersion programs, scouting, and other related school activities.
