RESPECTFULLY REQUESTING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLOR S. CERILLES, RMT, MAGD, THROUGH THE MUNICIPAL ENGINEERING OFFICE TO CONDUCT RELOCATION AND CLEARING OF MUNICIPAL STREETS PARTICULARLY THE OPEN-CUT FRONTING OF THE MUNICIPAL HALL OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Hermes B. Cabales to respectfully request the Local Chief Executive through the Municipal Engineering Office to conduct relocation and clearing of municipal street particularly the open cut fronting of the Municipal Hall of Dumalinao;

WHEREAS, Section 447, (a), (5) of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that the sangguniang bayan as the legislative body of the municipality, shall pass resolutions to ensure the efficient and effective delivery of the basic services and facilities as provided under Section 17 of this Code;

WHEREAS, it is the policy of the Local Government Unit of Dumalinao to maintain the safety, orderliness, and accessibility of municipal streets for the welfare of the public and to support efficient transport and pedestrian flow;



WHEREAS, the open-cut area fronting the Municipal Hall of Dumalinao has been identified as requiring attention for relocation and clearing to enhance accessibility, improve public safety, and ensure compliance with municipal infrastructure standards;

WHEREAS, the relocation and clearing of this municipal street section will contribute to the beautification of the town center, eliminate potential hazards, and provide a more welcoming and organized space for residents, visitors, and municipal employees;


WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. HERMES B. CABALES**, the body resolved, as it hereby resolves to favorably request the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD, through the Municipal Engineering Office to conduct relocation and clearing of municipal street particularly the open cut fronting of the Municipal Hall of Dumalinao, Zamboanga del Sur.

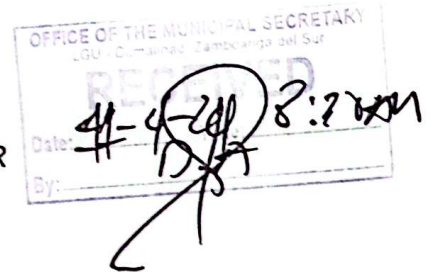

WHEREAS, the most appropriate and capacitated to do is the office of the municipal Engineer and the office of the Mayor, here this resolve;


NOW, therefore, premise above considered on motion by Honi. Julito Y. Apoya seconded by Hon. Erlando E. Gella, it was;
