**RESOLUTION NO. 0399-2024**

**APPROVING THE AUGMENTATION OF FUNDS FROM THE SAME EXPENSE CLASS OF MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) TO MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) OF THE PUBLIC EMPLOYMENT SERVICES OFFICE UNDER THE UNUTILIZED FUND OF OFFICE SUPPLIES AMOUNTING TO TWENTY THOUSAND PESOS (PHP20, 000.00) TO BE USED IN OTHER SERVICES THEREOF.**

**WHEREAS**, presented for consideration and appropriate action is the request of the PESO Manager to approve the augmentation of funds from the same expense class of MOOE to MOOE of the PESO in their unutilized fund of office supplies amounting to Php20, 000.00 to be used in other services thereof;

**WHEREAS**, Section 447, (a), (5) of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that the sangguniang bayan as the legislative body of the municipality, shall pass resolutions to ensure the efficient and effective delivery of the basic services and facilities as provided under Section 17 of this Code;

**WHEREAS**, the PESO has identified an unutilized fund under MOOE of its allocation for Office Supplies amounting to Php20, 000.00, which is available to fund this augmentation;



**WHEREAS**, there is a need to reallocate this unutilized fund within the same expense class to address other necessary services under the MOOE of PESO, ensuring efficient use of resources and continuity of operations;

**WHEREAS**, the augmentation of funds is in accordance with Section VII of Appropriation Ordinance No. 2023-12-497;

**WHEREAS**, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

**NOW, THEREFORE**, premises above-considered, on motion by **HON. FREDERICK R. BALANDRA**, the body resolved, as it hereby resolves to approve the augmentation of funds from the same expense class of Maintenance and Other Operating Expenses (MOOE) To Maintenance and Other Operating Expenses (MOOE) of the Public Employment Services Office (PESO) under the unutilized fund of office supplies amounting to Twenty Thousand Pesos (Php20,000.00) to be used in other services thereof.

**LET** the copy of this resolution be furnished to Local Chief Executive, Municipal Budget Office, Accounting Office, and concerned offices and/or officials for information, guidance, and appropriate action.


