WHEREAS, presented for consideration and appropriate action is the endorsement from the Municipal Health Office to adopt and endorse to the Integrated Provincial Health Office of Zamboanga del Sur, the approved Annual Operational Plan CY 2025 of RHU-Dumalinao;

WHEREAS, Section 447, (a), (5) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the sangguniang bayan as the legislative body of the municipality, shall pass resolutions to ensure the efficient and effective delivery of the basic services and facilities as provided under Section 17 of this Code;


WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;


