


ADOPTING THE APPROVED ANNUAL INVESTMENT PROGRAM (AIP) FOR CALENDAR YEAR 2025 OF MDC RESOLUTION NO. 6 SERIES OF 2024 OF THE MUNICIPAL DEVELOPMENT COUNCIL OF THE LOCAL GOVERNMENT UNIT OF DUMALINAO, PROVINCE OF ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the approved Annual Investment Program (AIP) for CY 2025 of MDC Resolution No. 6 Series of 2024 of the Municipal Development Council of the LGU-Dumalinao;

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise powers expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;
