RESOLUTION NO. 0405-2024

**ADOPTING THE SUPPLEMENTAL NO. 3 OF THE ANNUAL INVESTMENT
PLAN (AIP) 2024 OF THE LOCAL GOVERNMENT UNIT OF DUMALINAO,
PROVINCE OF ZAMBOANGA DEL SUR.**

WHEREAS, presented for consideration and appropriate action is the Supplemental No. 3 of the AIP 2024 of the LGU-Dumalinao;

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise powers expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, the Annual Investment Plan 2024 of the Municipality of Dumalinao includes the different programs and activities per sector and sub-sector, the work activities and financial plan for the 20% Development Plan, 5% GAD Plan, 5% DRRM, 1% PWD and Senior Citizen, 1% LCPC, Inter-Agency Aids, Statutory and Contractual Obligations, Personal Services, MOOE, Capital Outlay, and other funds from other sources of agencies;

WHEREAS, the Supplemental No. 3 of AIP 2024 has a total fund of Seven Hundred Forty-One Thousand Five Hundred Forty-Nine Pesos and Eighty-One Centavos (Php741, 549.81) to cover the implementation of the new Staffing Pattern and Organizational Structure of the Local Government Unit of Dumalinao and the expenditures of Indigenous Peoples Week Celebration, Lights



and Power Expenses, Rice Subsidy, Travelling Expenses, Representation Allowances and Other Service Expenses;

WHEREAS, there is a need to incorporate additional programs, projects, and activities in the AIP 2024 to respond to emerging needs, opportunities, and challenges faced by the municipality;


WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;
