**RESOLUTION NO. 0103-2022**

**AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLO S. CERILLES, RMT, MAGD, TO ENTER INTO A MEMORANDUM OF AGREEMENT BY AND BETWEEN THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG IX), REPRESENTED BY ITS REGIONAL DIRECTOR PAISAL O. ABUTAZIL, PHILIPPINE DRUG ENFORCEMENT AGENCY (PDEA IX), REPRESENTED BY ITS REGIONAL DIRECTOR EMERSON L. MARGATE, TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA IX), REPRESENTED BY ITS REGIONAL DIRECTOR DAN M. NAVARRO, DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE IX), REPRESENTED BY ITS REGIONAL DIRECTOR ATTY. ROY L. BUENAFE, DEPARTMENT OF HEALTH (DOH IX), REPRESENTED BY AGNES E. SOROÑGON, JR., FOR THE IMPLEMENTATION OF THE BALAY SILANGAN REFORMATION PROGRAM (BSRP) IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.**



**WHEREAS**, presented for consideration and appropriate action is the request of the Local Chief Executive to authorize her to enter into a Memorandum of Agreement (MOA) by and between the concerned departments and offices for the implementation of the Balay Silangan Reformation Program (BSRP) in the locality;

**WHEREAS**, Section 22 (c) of R.A 7160, otherwise known as the Local Government Code of 1991, provides, that every local government unit, as a corporation, shall, unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned;

**WHEREAS**, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444 (b) (1) (vi) thereof, which provides that upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, obligations, and such other documents made pursuant to law or ordinance;

**WHEREAS**, in accordance with the Department of Interior and Local Government (DILG) Memorandum Circular (MC) No. 2009-09 mandates that the Local Government Units support overall government efforts to address illegal drugs and other substances;

**WHEREAS**, the Balay Silangan Reformation Program (BSRP) provides intervention, counseling, and livelihood program for small-time drug offenders who are neither users nor dependents to help them to become more productive citizens in the society;

**WHEREAS**, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

**NOW, THEREFORE**, premises above-considered, on motion by **HON. JESSIE NIEL C. PAULO**, the body resolved, as it hereby resolves to authorize the Local Chief Executive, Honorable Mayor Junafior S. Cerilles, RMT, MAGD, to enter into a Memorandum of Agreement (MOA) by and between the Department of Interior and Local Government (DILG IX), represented by its Regional Director Paisal O. Abutazil, Philippine Drug Enforcement Agency (PDEA IX), represented by its Regional Director Emerson L. Margate, Technical Education and Skills Development Authority (TESDA IX), represented by its Regional Director Dan M. Navarro, Department of Labor and Employment (DOLE IX), represented by its Regional Director Atty. Roy L. Buenafe, Department of Health (DOH IX), represented by Agnes E. Fernando, MN, MPA, Ed.D, Department of Trade and Industry (DTI IX), represented by its Regional Director Al-zamir I. Lipae, Department of Education (DepEd IX), represented by Ernilyn E. Ligan, MAED, Dumalinao Workshop Center, represented by Rev. Christopher De Guzman, and Flex Fitness Gym, represented by Arturo A. Soroñgon, Jr., for the implementation of the Balay




Silangan Reformation Program (BSRP) in the Municipality of Dumalinao, Zamboanga del Sur.


