RESOLUTION NO. 0112-2022

AUTHORIZING THE GRANT OF RICE ASSISTANCE TO EMPLOYEES AND CONTRACT OF SERVICE/JOB ORDER WORKERS IN THE LOCAL GOVERNMENT UNIT OF DUMALINAO, ZAMBOANGA DEL SUR FOR CALENDAR YEAR 2022.

WHEREAS, presented for consideration and appropriate action is the grant of Rice Assistance to employees and Contract of Service/Job Order workers in the Local Government Unit of Dumaliniao, Zamboanga del Sur for CY 2022;

WHEREAS, President Ferdinand R. Marcos, Jr., issued Administrative Order No. 01, dated December 16, 2022, authorizing the one-time grant of rice assistance to all government employees and workers for fiscal year 2022 to recognize their collective and unceasing participation in and invaluable contribution to the efficient and responsive delivery of services to the public, especially in the midst of the COVID-19 pandemic;

WHEREAS, Section 6 of Administrative Order No. 02, Rice Assistance for Employees and COS/JO workers in LGUs states that the grant of the one-time rice assistance to employees and workers in LGUs, including those in the barangays, shall be determined by their respective sanggunians, a one-time rice assistance at a



uniform quantity of twenty-five (25) kilograms of rice each, depending on the LGU's financial capability, subject to the pertinent provision under RA No. 7160 or the "Local Government Code of 1991," and the conditions set forth under Section 2 hereof, chargeable against their respective FY 2022 local government funds;

WHEREAS, under Section 7 of Appropriation Ordinance No. 2021-12-461, states that the Municipal Mayor and the Municipal Vice Mayor are hereby authorized to augment any item of appropriation in this budget for their respective executive and legislative officers by the way of Executive Order and Resolution respectively, from appropriation savings, within the same expense class of the office;

WHEREAS, the available Maintenance and Other Operating Expenses (MOOE) Savings of Non-Office, covering the COVID Response that shall be used to augment funds to MOOE of the municipality to appropriate the grant of rice assistance to employees and COS/JO workers with the total amount of Two Hundred Seventy Thousand Pesos (Php270, 000.00), to wit:

WHEREAS, the Municipal Budget Officer had certified that as per book of accounts of the said offices, the various items was found out available as of date and can be a source of augmentation;

WHEREAS, to date, the municipality has a total of Two Hundred Sixty-Nine (269) employees and COS/JO workers entitled to receive the rice assistance under Administrative Order No. 02;

WHEREAS, the LGU-Dumalinao has sufficient budget to cover the one-time grant of rice assistance at a uniform quantity of twenty-five (25) kilograms of rice each for employees and COS/JO workers in the total amount of Php270, 000.00;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. HERMES B. CABALES**, the body resolved, as it hereby resolves to authorize the grant of Rice Assistance to employees and Contract of Service/Job Order workers in the Local Government Unit of Dumalinao, Zamboanga del Sur for CY 2022.


