**RESOLUTION NO. 012-2022**

**RECOMMENDING TO THE LOCAL INTER-AGENCY TASK FORCE COUNCIL OF DUMALINAO, ZAMBOANGA DEL SUR TO ALLOW THE PANTAWID PAMILYANG PILIPINO PROGRAM (4PS) OF DUMALINAO, ZAMBOANGA DEL SUR TO CONDUCT A FAMILY DEVELOPMENT SESSIONS (FDS) FACE TO FACE MEETING WITH THE 4PS BENEFICIARIES WITHIN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.**

**WHEREAS**, presented to this august body for appropriate action is the request of the 4Ps Municipal Link, represented by Ms. Cherry Leine A. Resaba, RSW, to allow them to conduct face-to-face Family Development Session (FDS) with the 4Ps beneficiaries within the locality;

**WHEREAS**, the 4Ps program provides conditional cash grants to the poorest of the poor to improve the health, nutrition, and education of children aged 0-18;

**WHEREAS**, in the said program, the household beneficiaries and the parents/guardian must attend the Family Development Sessions (FDS), which include topics on responsible parenting, health, and nutrition;



**WHEREAS**, the LGU-Dumalinao ensures and supports the 4Ps Programs to alleviate the beneficiaries from poverty and remain non-poor during and after the conditional cash grant;

**WHEREAS**, the august body acknowledges the importance of the Family Development Sessions (FDS) and, at the same time, the health and safety of the parents/guardian and 4Ps facilitators;

**WHEREAS**, after careful review and exhausted deliberation, and after finding the same to be proper and order;
