RESOLUTION NO. 0126-2023

ENABLING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLO R. S. CERILLES, RMT, MAGD, TO ISSUE AN EXECUTIVE ORDER (EO) MANDATING THE LOCAL GOVERNMENT UNIT OF DUMALINAO TRAFFIC ENFORCER TO CONDUCT TRAFFIC ENFORCEMENT OPERATIONS DURING SUNDAY-TABO WITH CORRESPONDING WAGES THEREOF.

WHEREAS, presented for consideration and appropriate action the proposed resolution of Hon. Hermes B. Cabales to enable the Local Chief Executive, Honorable Mayor Junaflo R. S. Cerilles, RMT, MAGD, to issue an Executive Order (EO) mandating the LGU-Dumalinao Traffic Enforcer to conduct traffic enforcement operations during Sunday-Tabo with corresponding wages thereof;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;



WHEREAS, Section 444 (2) in the above Code, provides that the Municipal Mayor, as the local chief executive of the municipal government, shall exercise such powers and perform such duties and functions as provided by the code and other laws;

WHEREAS, as the year 2023 starts, several activities and concerns, both economic and preventive traffic management and safety measures, which personnel and services are hereby sought, in the parking area, public market, traffic congestion, and violation;

WHEREAS, accordingly, personnel hereof are more than willing to render services during Sunday-Tabo and/or which necessity arises in connection to the traffic management operations with corresponding wages thereof, which is deemed proper as compensation for their services;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. HERMES B. CABALES**, the body resolved, as it hereby resolves to enable the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD, to issue an Executive Order (EO) mandating the Local Government Unit of Dumalinao Traffic Enforcer to conduct traffic enforcement operations during Sunday-Tabo with corresponding wages thereof.
