RESOLUTION NO. 0129-2023

AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLO R. S. CERILLES, RMT, MAGD, TO ENTER INTO A MEMORANDUM OF PARTNERSHIP AGREEMENT (MOPA) BY AND BETWEEN DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, REGION IX, REPRESENTED BY RONALD D. GADOT, OFFICE IN CHARGE-ASSISTANT REGIONAL DIRECTOR FOR TECHNICAL SERVICES FOR THE JOINT IMPLEMENTATION OF THE ZAMBOANGA DEL SUR PROVINCIAL FORESHORE DEVELOPMENT AND MANAGEMENT PLAN.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Romeo G. Ligan to authorize the Local Chief Executive to enter into a Memorandum of Partnership Agreement (MOPA) by and between DENR, Region IX, for the joint implementation of the Zamboanga del Sur Provincial Foreshore Development and Management Plan;

WHEREAS, Section 22 (c) of R.A 7160, otherwise known as the Local Government Code of 1991, provides, that every local government unit, as a corporation, shall, unless otherwise provided in this Code, no contract may be entered into by the



local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned;

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444 (b) (1) (vi) thereof, which provides that upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, the Foreshore Development and Management Plan is a Ten (10) year plan envisioned to improve the management and resource protection of foreshore areas and improve the undeveloped foreshores, to make a productive, economically and ecologically sound ecosystem;

WHEREAS, the Local Government Unit of Dumalinao implement environmental protection programs and projects as well as enforcing laws and regulations;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. ROMEO G. LIGAN**, the body resolved, as it hereby resolves to authorize the Local Chief Executive, Honorable Mayor Junafior S. Cerilles, RMT, MAGD, to enter into a memorandum of partnership agreement (MOPA) by and between the Department of Environment and Natural Resources, Region IX, represented by Ronald D. Gadot, Office In Charge-Assistant Regional Director for Technical Services for the joint implementation of the Zamboanga del Sur provincial foreshore development and management plan.

**MEMORANDUM OF PARTNERSHIP AGREEMENT
(M O P A)**

For the joint implementation of the Zamboanga del Sur Provincial Foreshore Development and Management Plan CY 2022-2032

This **AGREEMENT** is made and entered into by and between:

The **LOCAL GOVERNMENT UNITS** of Zamboanga del Sur created under existing laws of the Republic of the Philippines, with post office address known to us of represented herein by each respective Mayors who are involved in their capacity as Municipal and City Mayor representing their office, hereinafter referred to as the Local Government Units.

The **PROVINCIAL AND DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, REGION IX**, a National government agency, with principal address at President Corazon C. Aquino Regional Government Center, Balintawak, Pagadian City, represented by **RONALD D. GADOT** in his capacity as In-charge, Office of the Regional Executive Director and OIC, Assistant Regional Director for Technical Services, hereinafter referred to as the **DENR-IX**

WITNESSETH:

WHEREAS, Under the Local Government Code of the 1987 Philippine Constitution provides that the state shall protect and advance the right of the people to a balance ecology in accord with the rhythm and harmony of nature

WHEREAS, the Zamboanga del Sur Foreshore Development and Management Plan or ZDSFDMP cy 2022-2023 was formulated through the collective efforts of the Local Government Units, National Government Agencies and relevant stakeholders whom we refer to as overseers and implementers of the plan.

WHEREAS, the ZDSFDMP was recommended by the DENR Regional and LGU Planning Advisory Group, presented to the Stakeholders and was subsequently adopted.

WHEREAS, the DENR, Region IX, recognizes the vital role of the Local Government in pushing forward for the realization of the objectives of the said Ten-year plan; and that establishing partnerships with the Local Government Units (LGUs) of the Municipalities and the city of Pagadian in the Province of Zamboanga del Sur in the implementation of the same strengthen collaboration between them in foreshore administration, management and protection;

WHEREAS, the parties, also recognized the importance of such partnership envisioned to improve the management and resource protection of its foreshore areas stride and manifest commitments between them towards improving and developing the undeveloped foreshores making it productive, economically and ecologically sound ecosystems;

WHEREAS, the Department of Environment and Natural Resources Region IX and the coastal Municipalities/City have agreed to forge this partnership agreement towards achieving common goal of providing efficient foreshore related services for the communities/investors through collaboration in the implementation of the **ZAMBOANGA DEL SUR FORESHORE MANAGEMENT AND DEVELOPMENT PLAN**;

WHEREAS, the implementer LGUs committed to improve, protect, develop and manage the foreshore areas of the Province and the City of Pagadian.

WHEREAS, the DENR together with other National Government Agencies and the Local Government Units mutually agree to be bound in partnership to implement the plan towards a common goal of attaining the ZDFMDP Vision: *"Sustainably develop foreshore areas in the province of Zamboanga del Sur, governed by united, responsible and law abiding people working together for the environment and a self-reliant community"*

NOW, THEREFORE, for and in consideration of the following premises, the parties do hereby agree and declare:

A. ROLES AND RESPONSIBILITIES OF THE DENR

1. Conduct of inventory, and mapping of foreshore areas prone to floods/ disasters and other natural calamities within the territorial jurisdiction of the Municipality, Province of Zamboanga del Sur, particularly within foreshore areas.
2. Assist the LGU in identifying a resettlement area for the affected individuals residing in the high risk zones and provide manpower and technical assistance in the conduct of this activity.
3. Support in data management and provide electronic and paper based thematic map and technical data related to the management of foreshore areas and designating a setback area from shorelines;
4. To join with the LGU in the conduct of IEC and related activities for the conservation and protection of foreshore areas;
5. To Issue industrial and commercial permits/provisional Foreshore Lease agreements/permits to Foreshore Occupants/claimants;
6. Assist the LGU in the formulation of project proposals related to foreshore management and lobby for funding;
7. To recommend to LGU the highest and best use of Foreshores for their recognition and implementation;
8. To collaborate with NGAs, stakeholders and partners in order to provide biophysical and socio economic monitoring, coastal law enforcement and other aspects in the implementation of the PFDMP.

B. ROLES AND RESPONSIBILITIES OF THE CITY/MUNICIPALITIES PROVINCE OF ZAMBOANGA DEL SUR

1. Provide manpower to assist DENR in the conduct of coastal hazard assessment and mapping of flood prone areas or natural calamity areas where the community reside for purposes of resettlement of informal settlers and foreshore rehabilitation;
2. Recommend and provide database of foreshore areas that are needed for industrial, commercial and recreational use;
3. Spearhead Community and Social Mobilization for purposes of development and management of foreshore in order to support activities to foreshore area beneficiaries;
4. File request / application for issuance of foreshore lease agreement or provisional permit by DENR;
5. Improve structural and natural drainage system in coastal settlement areas;
6. Integrate the foreshore plan in the local/LGU infrastructure coastal plan or investment plan use;
7. Prepare a zoning management map for Tourism, Industrial and Commercial use Zone within their respective foreshore areas.

8. To promote and complement the development and management initiatives as defined in the DENR ZDS Provincial Foreshore Development and Management Plan (PFDMP) cy 2022-2023
9. To support the creation of Zamboanga del Sur Foreshore Development and Management Council by recommending an official representative. This to be composed of the following:

CO-Chair : Municipal Mayors

10. To provide the necessary feedback in order to assess level of community support, socio economic impacts and issues and concerns that may emerge in the implementation of PFDMP.
11. To render monitoring and evaluation report, analysis and recommendations thereon for enhancement of plan implementation.
12. To institutionalize the adoption of the plan through local legislation or LGUs resolution.

C. AMENDMENTS

The parties shall mutually agree upon any propose amendment to this partnership agreement.

D. EFFECTIVITY

This Agreement shall take effect upon the signing by the representatives of the parties hereto and shall remain in full force and effect.
