#### **RESOLUTION NO. 0141-A-2023**

EARNESTLY REQUESTING THE REGIONAL DIRECTOR OF THE DEPARTMENT OF AGRICULTURE (DA) REGION-IX, DIR. DENNIS R. ARPIA, THROUGH THE PHILIPPINE CENTER FOR POSTHARVEST DEVELOPMENT AND MECHANIZATION (PHILMECH) TO PROVIDE ONE (1) UNIT COMBINE RICE HARVESTER IN THE MUNICIPALITY OF **DUMALINAO, ZAMBOANGA DEL SUR.** 

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Romeo D. Parila to earnestly request the Department of Agriculture (DA) Region-IX, through the Philippine Center for Postharvest Development and Mechanization (PHILMECH) to provide one (1) unit Combine Rice Harvester in the locality;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare:





WHEREAS, the Municipality of Dumalinao is a 4th class municipality in the Province of Zamboanga del Sur, which is politically subdivided into 30 barangays with an estimated population of 32, 013; facilitator

WHEREAS, Dumalinao is an agricultural municipality wherein a large group of population is engaged in farming activities as their primary source of livelihood. In the same manner, they are the ones providing agricultural products to the municipality as well as the neighboring municipalities in the province in such a way that they are earning as well;

WHEREAS, the abovementioned machinery will help the farmers organization for their smooth and faster rice production and at the same time, to less their harvest expenses thereof;

WHEREAS, considering the limited resources of the Local Government Unit of Dumalinao, this august body deemed it necessary to request the PHilMech for the provision of the said equipment;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. ROMEO D. PARILA, the body resolved, as it hereby resolves, to earnestly request the Regional Director of the Department of Agriculture (DA) Region-IX, Dir. Dennis R. Arpia, through Philippine Center for Postharvest Development and Mechanization (PHILMECH) to provide one (1) unit Combine Rice Harvester in the Municipality of Dumalinao, Zamboanga del Sur.
