**RESOLUTION NO. 0142-2021**

**RESOLUTION RECOMMENDING TO THE LOCAL CHIEF EXECUTIVE FOR THE TEMPORARY CLOSURE AND STOPPAGE OF THE OPERATION OF THE SOUTHERN MILLING CORPORATION FOR HAVING COMMITTED VARIOUS ENVIRONMENTAL VIOLATIONS**

**WHEREAS**, on September 24, 2020, the office of the Municipal Environment and Natural Resources Office (MENRO) together with the Environmental team composed of the Office of the Municipal Planning and Development, Municipal Engineering Office and Municipal Health Office conducted a second visit to the Southern Milling Corporation in order to evaluate and determine if it has complied the two-month period within which to effect necessary solutions to their violations;

**WHEREAS**, SB Resolution No. 0120-2020 provides the management of Southern Milling Corporation a two-month period starting from July 15, 2020 to September 15, 2020 in order to correct their violations;

**WHEREAS**, per inspection of the MENRO office together with the team dated September 24, 2020, Southern Milling Corporation has failed in instituting



necessary solutions to their violations and the same industry continues to be a health nuisance in the place.

**WHEREAS**, sighted herewith are the recommendations of the team as follows:

1. That two (2) Standard Industrial Dust Collectors shall be established as soon as possible;
2. That the structure of the building shall be renovated to enclose the site to avoid air pollution;
3. The company shall be required to have a Waste Disposal Management Plan; and
4. That the law making body of LGU-Dumalinao shall pass a resolution to temporarily stop the operation of the Southern Milling Corporation immediately until the above-mentioned recommendation be settled.

**NOW, THEREFORE**, premises above-considered, on motion by **HON. ROMEO G. LIGAN** the body resolved, as it hereby resolves to recommend to the Local Chief Executive, this municipality for the temporary closure and stoppage of the operation of Southern Milling Corporation located at Brgy. Pag-asa, Dumalinao, Zamboanga del Sur until full compliance of the recommendations by the environmental team.

**LET** copy of this resolution be furnished to concern offices and/or officials for reference, guidance and appropriate action.
