RESPECTFULLY REQUESTING ENGR. INOCENCIO P. SABUGAL, DISTRICT ENGINEER OF ZAMBOANGA DEL SUR, 2ND DISTRICT ENGINEERING OFFICE OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS THROUGH ENGR. EDWIN EGAMA, CHIEF OF CONSTRUCTION DIVISION, TO SUBMIT A STATUS REPORT IN THE OFFICE OF THE SANGGUNIANG BAYAN OF DUMALINAO WITH REGARDS TO THE ROAD CONCRETING PROJECT AT BARANGAY PAGLAUM, MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Frederick R. Balandra to request the DPWH-Zamboanga del Sur, 2nd District Engineering Office to submit a status report of the road concreting project at Barangay Paglaum in the locality;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective



governance, and those which are essential to the promotion of the general welfare;

WHEREAS, the construction of the said road project has been started for quite some time and within the jurisdiction of the Local Government Unit of Dumalinao, Zamboanga del Sur;

WHEREAS, the LGU-Dumalinao has been receiving negative feedback and issues concerning road safety from Barangay Paglaum to Barangay Upper Dumalinao, such as the nonexistence of road shouldering and the presence of road islands, which made the said road to be narrow and dangerous to the motorist and pedestrian, especially elementary and high school teachers and students. In fact, many vehicular accidents has been reported, particularly in the abovementioned area;

WHEREAS, the august body finds it necessary to humbly request the concerned office to submit a status report to the Office of the Sangguniang Bayan for information and guidance on the said government projects constructed within the locality;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. FREDERICK R. BALANDRA**, the body resolved, as it hereby resolves to respectfully request Engr. Inocencio P. Sabugal, District Engineer of Zamboanga del Sur, 2nd District Engineering Office of the Department of Public Works and Highways through Engr. Edwin Egama, Chief of Construction Division, to submit a status report of the road concreting project at Barangay Paglaum, Dumalinao, Zamboanga del Sur.

LET the copy of this resolution be furnished to concern offices and/or officials for reference, guidance and appropriate action.

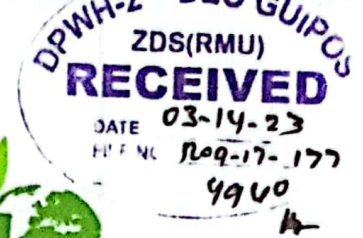


