RESOLUTION NO. 0155-2021

RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM THE DEPARTMENT OF AGRICULTURE SECRETARY HONORABLE WILLIAM DAR AMOUNTING TO TEN MILLION PESOS (Php10, 000, 000.00) FOR THE IMPLEMENTATION OF FARM TO MARKET ROAD PROJECT FROM BARANGAY BAG-ONG MISAMIS TO BARANGAY BAG-ONG SILAO ROAD CONCRETING IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR

WHEREAS, the specific provision of R.A. 7160, otherwise known as the Local Government Code of 1991, delegated functions and responsibilities to Local Government Units (LGUs), primarily on the effective and efficient delivery of services and facilities at the local level:

WHEREAS, there is a necessity to provide fund assistance to LGUs in order to alleviate their financial burden in carrying out the devolved functions and responsibilities, as specified by law;

WHEREAS, the Municipality of Dumalinao is a 4th class municipality in the Province of Zamboanga del Sur which is politically subdivided into 30 barangays with an estimated population of 32, 013 people;

WHEREAS, Barangay Bag-ong Misamis and Barangay Bag-ong Silao are an agricultural barangay in which majority of the inhabitants are engaged in farming and planting agricultural products as their main source of livelihood. In the same manner, they are the ones providing agricultural products to the municipality as well as the neighboring municipalities in the province in such a way that they are earning as well;

WHEREAS, the farmers have experienced difficulties in transporting their products outside their barangay because of unfavorable road condition. At most they will seek the services of some individuals for a fee in order to transport their products which entail additional cost for them, not to mention that they have yet to sell their products in the market;

WHEREAS, the road concreting project will provide a vast tract of agricultural products that would reap the benefit of an easy access to the market and consequently it will benefit not only the domestic tourism but more importantly to upland and lowland farmers;

WHEREAS, the Department of Agriculture is a national agency that is mandated to promote agricultural development that are responsive to the needs of the people in the pursuit of national development;

NOW, THEREFORE, premises above-considered, on motion by HON. GERARDO Y. GAMAL the body resolved, as it hereby resolves to request financial assistance from the Department of Agriculture Secretary Honorable William Dar amounting to Ten Million Pesos (Php10, 000, 000.00) for the implementation of Farm to Market Road Project from Barangay Bag-ong Misamis to Barangay Bag-ong Silao road concreting project in the municipality of Dumalinao, Zamboanga del Sur.
