

RESOLUTION GRANTING AUTHORITY TO THE HONORABLE MAYOR JUNAFLOR S. CERILLES, RMT, MAGD, DUMALINAO, ZAMBOANGA DEL SUR, TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN NATIONAL POLICE COMMISSION REPRESENTED BY ITS REGIONAL DIRECTOR BENJAMIN DE AUSEN FLORENTINO, CESO IV AND DUMALINAO MUNICIPAL POLICE STATION REPRESENTED BY THE CHIEF OF POLICE PCPT JOEL M. GALERIANA FOR THE IMPLEMENTATION OF COMMUNITY AND SERVICE-ORIENTED POLICING AS THE FOUNDATION AND BACKBONE OF COMMUNITY-ORIENTED POLICING AND CRIME PREVENTION IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR
