RESOLUTION NO. 0162-2023

PROHIBITING THE USE OF SANGGUNIANG BAYAN SESSION HALL OF DUMALINAO, ZAMBOANGA DEL SUR, AS THE VENUE OF ANY MEETINGS, SEMINARS, AND SIMILAR ACTIVITIES BY ANY OFFICE, GOVERNMENT AND NON-GOVERNMENT ORGANIZATION EXCEPT FOR THE CONDUCT OF EXECUTIVE AND LEGISLATIVE MEETINGS IN THIS MUNICIPALITY.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Romeo D. Parila to prohibit the use of Sangguniang Bayan Session Hall of Dumalinao, Zamboanga del Sur, as the venue of any meetings, seminars, and similar activities by any office, government and non-government organization except for the conduct of Executive and Legislative meetings in this municipality;

WHEREAS, Sangguniang Bayan Session Hall is a place where the Sangguniang Bayan holds its meetings to discuss and deliberate on issues and concerns affecting the municipality through passing local laws or ordinances, approving the annual budget, and exercising oversight over the activities of the local government;

WHEREAS, the office of SB as a whole stores and maintains various office files and documents relating to its day to day course of business which are vital and important. These files must at all times be preserved and protected;



WHEREAS, it cannot be denied that the SB Session Hall for the past years up to present has been used as venue for the conduct of meetings, short seminars, and other short course session by government and non-government organization and even by some offices of this municipality;

WHEREAS, the usage of the SB Session Hall as mentioned above other than the normal use of Sangguniang Bayan members to its own premises had impeded its official use, especially during committee hearing not to mention for possible loss/damage of files/documents due to large attendance of attendees;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. ROMEO D. PARILA** the body resolved, as it hereby resolves to prohibit the use of Sangguniang Bayan Session Hall of Dumalinao, Zamboanga del Sur, as the venue of any meetings, seminars, and similar activities by any office, government and non-government organization except for the conduct of Executive and Legislative meetings in this municipality;
