**RESOLUTION SUPPORTING AND ENDORSING THE REQUEST OF HONORABLE MAYOR JUNAFLO R. CERILLES ASKING FOR FINANCIAL SUPPORT FROM PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR) THROUGH ITS CHAIRMAN AND CHIEF EXECUTIVE ANDREA D. DOMINGO, THE PROJECT "MULTI-PURPOSE BUILDING" FOR THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR**

**WHEREAS**, presented to this august body is the request of the Municipal Mayor Junaflo R. Cerilles asking for financial support from Philippine Amusement and Gaming Corporation (PAGCOR) through its Chairman and Chief Executive Andrea D. Domingo, the project "Multi-Purpose Building" for the Municipality of Dumalinao, Zamboanga del Sur;

**WHEREAS**, the specific provision of R.A. 7160, otherwise known as the Local Government Code of 1991, delegated functions and responsibilities to Local Government Units (LGUs), primarily on the effective and efficient delivery of services and facilities at the local level;

**WHEREAS**, there is a necessity to provide fund assistance to LGUs in order to alleviate their financial burden in carrying out the devolved functions and



responsibilities, as specified by law, especially so, that the Municipality of Dumalinao is a 4<sup>th</sup> class municipality in the Province of Zamboanga del Sur which is politically subdivided into 30 barangays with an estimated population of 32, 013 people;

**WHEREAS**, in consonance with one of the national thrust against poverty particularly in the rural areas, there is a need to properly address the indispensable request of the barangay populace through the all-weather and quality "Multi-Purpose Building" to be used for emergency purposes
