AUTHORIZING THE LOCAL CHIEF EXECUTIVE. HONORABLE MAYOR JUNAFLOR S. CERILLES, RMT, MAGD, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF DUMALINAO WITH DEPARTMENT OF HEALTH ZAMBOANGA PENINSULA-CENTER FOR HEALTH DEVELOPMENT, REPRESENTED BY ITS OFFICER IN CHARGE-REGIONAL DIRECTOR JOSHUA G. BRILLIANTES, MD, MPH, CESO IV, FOR THE IMPLEMENTATION OF HEALTH FACILITIES ENHANCEMENT PROGRAM-CENTER FOR HEALTH DEVELOPMENT IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the letter request of the Municipal Health Officer to authorize the Local Chief Executive to enter into and sign a MOA on behalf of the LGU-Dumalinao with DOH Zamboanga Peninsula-Center for Health Development for the implementation of Health Facilities Enhancement Program-Center for Health Development in the locality;

WHEREAS, Section 22 (c) of R.A 7160, otherwise known as the Local Government Code of 1991, provides, that every local government unit, as a corporation, shall, unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned;

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444 (b) (1) (vi) thereof, which provides that upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, the General Appropriation Act of 2023 provides the total amount of One Million Eight Hundred Thousand Pesos (Php1, 800, 000.00) for infrastructure to the CHD-9 for the Municipality of Dumalinao for the construction of the new Barangay Health Station;

WHEREAS, the abovementioned project shall provide first aid, maternal and child health care, and other basic health services to all constituents of the barangay and other neighboring areas;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. JELITO R. PEÑONAL, the body resolved, as it hereby resolves, to authorize the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD, to enter into and sign a Memorandum of Agreement (MOA) on behalf of the Local Government Unit of Dumalinao with Department of Health Zamboanga Peninsula-Center for Health Development, represented by its Officer In Charge-Regional Director Joshua G. Brilliantes, MD, MPH, CESO IV, for the implementation of Health Facilities Enhancement Program-Center for Health Development in the Municipality of Dumalinao, Zamboanga del Sur.

MEMORANDUM OF AGREEMENT

(DOH-Implemented)

KNOW ALL MEN BY THESE PRESENTS:

This agreement is entered into by and between:

The ZAMBOANGA PENINSULA - CENTER FOR HEALTH DEVELOPMENT, with office address at Upper Calarian, Zamboanga City, represented by DIR. JOSHUA G. BRILLANTES, MD, MPH, CESO IV in his capacity as the OIC - Director IV, herein referred to as "CHD-9"

and

The Municipality of Dumalinao with office address at Municipal Hall, Municipality of Dumalinao, Province of Zamboanga del Sur herein represented by HON. JUNAFLOR S. CERILLES in her capacity as Mayor, hereinafter referred to as "LGU"

WITNESSETH

WHEREAS, The government's mandate on Universal Health Care (UHC), through the Department of Health's "FOURmula ONE for Health (F1+ for Health)", commits to achieve the overall health system goals of improved health outcomes, financial risk protection, and responsiveness under the Health Facilities Enhancement Program(HFEP).

WHEREAS, The Health Facilities Enhancement Program (HFEP) serving as the national government's major strategy to provide assistance to government – owned healthcare facilities for improvement of infrastructure, equipment upgrades, medical transport such as mobile dental vans and ambulances, and acquisition of land for health facility expansion. The different project proposals are approved annually and allocated funds under HFEP.

WHEREAS, the General Appropriation Act 2023 provides the total amount of *One Million Eight Hundred Thousand Pesos* (Php 1,800,000.00) for infrastructure to the CHD-9 for the Municipality of Dumalinao, breakdown as follows;

NOW THEREFORE, in consideration of the foregoing premises and stipulations herein set forth, the Parties hereto agreed and do hereby agree as follows:

A. FUND SCHEDULE

1. The funds are available until December 31, 2023.

B. RESPONSIBILITIES OF THE LGU:

The responsibilities of the MUNICIPALITY/CITY/PROVINCE are as follows:

 The Municipality/City/Province will provide yearly at least One percent (1%) of the total budget for health for the continuing maintenance of the infrastructure project.

- 2. Ensure the site is suitable and free of any issue pertaining to possession and/or ownership as evidence by land title in the name of the Municipality/City/Province or any deed or instrument showing the property subject of the infrastructure project is absolutely owned by the Municipality/City/Province.
- 3. Ensure that adequate MOOE funds will be provided for the operations of the facility commensurate to its level or category.
- 4. Apply and acquire a Permit to Construct (PTC) from the Licensing Division of CHD-9 for facilities that needs to be licensed eg. Birthing Facilities and Hospitals.
- 5. Prepare and submit standard floor plans (If not New Construction, Existing Floor Plan, Proposed Schematic Floor Plan and Scope of Work/Technical Specification) required for CHD preparation of DAED, Detailed Estimates, PERT/CPM Program of Works and BOQ for Project Procurement.
- 6. Allow representative of the Municipal/City/Province Engineers Office to be a resident Engineer who will regularly monitor and inspect the progress of construction and submit report to the CHD-9.
- 7. Attend monitoring meetings called by the CHD-9 and act immediately on observations made by the Regional Office requiring corrections and assist revisions in construction.
- 8. Raise to CHD-9 for arbitration, any conflicts in construction and seek the clearance and approval first of the CHD-9 for any proposed Variation orders in construction.
- 9. Upon recommendation of the CHD-9, the Municipalities/Cities/Province shall accept the project upon completion, sign the Certificate of Turn-over and shall record the same to the LGU Journal Entry Voucher (JEV). Provide the CHD-9 copy of the JEV.
- 10. Provide the Human Resource complement to make the facility fully functional and operational in accordance with licensing standards.
- 11. Attain four-in-one (4 in 1) accreditation with Philhealth for RHU/CHO or BHS as may be applicable.
- 12. Submit reports as may be required by the CHD-9.
- 13. To send designated observer during the conduct of bidding.

C. RESPONSIBILITIES OF THE CHD-9:

The responsibilities of the CHD-9 are as follows:

- 1. Ensure that funds as mentioned are available;
- Administer/implement the Construction/Repair/Renovation/Upgrading of the various health care facilities based on the plans and specifications.
- 3. Ensure that Schematic Plans of infrastructure projects are made according to existing government standards for construction
- Undertake all procurement of goods and/or civil works projects through Public Bidding in accordance with the provision of RA 9184, otherwise known as Government Procurement Reform Act;
- 5. Will coordinate closely with the Municipal/City/Province Engineer Office during monitoring, supervision, revision and amendment of projects.
- Shall provide copy to the LGU Engineering Office the approved POW, DAED and other documents.

- Thru the implementing contractor, Secure/Pay for the construction building permit and other legal fees for the said construction.
- Shall invite representative from LGU during the conduct of bidding.
- 9. Conduct regular monitoring and evaluation of the facilities.
- 10. Shall Turn Over the project with Deed of Donation to the LGU upon completion
- 11. Ensure that utilization of funds shall follow the usual budgeting, accounting and auditing rules and regulations.

D. AMENDMENTS:

This Memorandum of Agreement may be amended only upon mutual consent of both Parties provided that all amendments shall be incorporated way of reference as integral parts of this MEMORANDUM OF AGREEMENT.

E. REVOCATION:

This Memorandum of Agreement shall be revoked at any time at the instance of the CHD-9 should the Municipality/City/Province fail to comply with any of the foregoing provisions stated above.

F. EFFECTIVITY:

This Memorandum of Agreement shall be effective on the date of Notarization
