RESOLUTION SUPPORTING THE PROGRAM FOR THE IMPLEMENTATION OF THE KALAHI-CIDSS-KKB BALIK PROBINSYA BAGONG PAG-ASA PROGRAM OF THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) IN THE MUNICIPALITY OF DUMALINAO, PROVINCE OF ZAMBOANGA DEL SUR AND PROVIDE 20% LOCAL COUNTERPART THEREOF

WHEREAS, presented to this august body for appropriate action, is the request of the Local Chief Executive to support the program for the implementation of the KALAHI-CIDSS-KKB Balik Probinsya Bagong Pag-Asa Program of the Department of Social Welfare and Development (DSWD) in the Municipality of Dumalinao, Zamboanga del Sur and provides 20% local counterpart thereof;

WHEREAS, the Kapit Bisig sa Kahirapan-Comprehensive and Integrated Delivery of Social Services Kapangyarihan at Kaunlaran sa Barangay Balik Probinsya Bagong Pag-asa (KC-KKB BP) programs and projects which focuses on supporting livelihood related priorities of communities that generate and diversify the income of households using the CDD approach;



WHEREAS, the Local Government Unit of Dumalinap, Zamboanga del Sur agree to engage in partnership in implementing KALAHI-CIDSS-KKB BP2 with the objective of reducing poverty in the municipality through developing and implementing social protection programs;

WHEREAS, the Department of Social Welfare and Development through KALAHI CIDSS KKB provides support mechanism to LGUs to assist them with the projects needed for the development or rehabilitation of an area to be an adequate resettlement/relocation to the affected individuals and families;

WHEREAS, the Municipality of Dumalinap shall receive a grant amounting to Seven Million Five Hundred Thousand Pesos Only (Php7, 500,000.00);

WHEREAS, the LGU will provide 20% of the Municipal Grant amounting to One Million Five Hundred Thousand Pesos only (Php1, 500, 00.00) to support the subproject implementation and other related activities;


WHEREAS, after careful review and exhausted deliberation, finding the same sound, proper, and in order;

NOW, THEREFORE, premises above-considered, on motion by **HON. ARNOLD L. FLORES** the body resolved, as it hereby resolves to support the program for the implementation of the KALAHI-CIDSS-KKB Balik Probinsya Bagong Pag-Asa Program of the Department of Social Welfare and Development (DSWD) in the Municipality of Dumalinap, Zamboanga del Sur and provides 20% local counterpart thereof.


