RESOLUTION REQUESTING THE HONORABLE WENDEL E. AVISADO, SECRETARY OF DEPARTMENT OF BUDGET AND MANAGEMENT FOR FUNDING ALLOCATION OF BARANGAY ROAD CONCRETING PROJECT FARM TO MARKET ROAD (FMR) SECTION BARANGAY TINA TO BARANGAY BALOBOAN AMOUNTING TO TEN MILLION (PHP10, 000, 000.00) IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA **DEL SUR**

WHEREAS, presented to this august body for appropriate action, is the request of the Local Chief Executive to request the Honorable Wendel E. Avisado, Secretary of Department of Budget and Management for funding allocation of barangay road concreting project Farm to Market Road (FMR) section Barangay Tina to Barangay Baloboan amounting to Ten Million (Php10, 000, 000.00) in the Municipality of Dumalingo, Zamboanga del Sur;

WHEREAS, the Municipality of Dumalinao is a 4th class municipality in the Province of Zamboanga del Sur which is politically subdivided into 30 barangays with an estimated population of 32, 013 people;

WHEREAS, Barangay Tina and barangay Baloboan are an agricultural barangay in which majority of the inhabitants are engaged in farming and planting agricultural products as their main source of livelihood. In the same manner,



they are the ones providing agricultural products to the municipality as well as the neighboring municipalities in the province in such a way that they are earning as well;

WHEREAS, the farmers have experienced difficulties in transporting their products outside their barangay because of unfavorable road condition. At most they will seek the services of some individuals for a fee in order to transport their products which entail additional cost for them, not to mention that they have yet to sell their products in the market;

WHEREAS, the concreting project will provide a vast tract of agricultural products that would reap the benefit of an easy access to the market and consequently it will benefit not only the domestic tourism but more importantly to upland and lowland farmers;

WHEREAS, after finding the same to be of great importance and help, this august body finds it necessary to request funds to allocate the road concreting project Farm to Market Road (FMR);

NOW, THEREFORE, premises above-considered, on motion by HON. ROLLY L. CHING the body resolved, as it hereby resolves august body for appropriate action, is the request of the Local Chief Executive to request the Honorable Wendel E. Avisado, Secretary of Department of Budget and Management for funding allocation of barangay road concreting project Farm to Market Road (FMR) section Barangay Tina to Barangay Baloboan amounting to Ten Million (Php10, 000, 000.00) in the Municipality of Dumalinao, Zamboanga del Sur.
