RESOLUTION NO. 0171-2023

RESPECTFULLY REQUESTING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLOR S. CERILLES, RMT, MAGD, TO CREATE AN AD HOC COMMITTEE AS A NEGOTIATING BODY FOR THE ACQUISITION OF LAND WHICH HAS POTENTIAL SOURCE OF POTABLE WATER WITHIN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Hermes B. Cabales, requesting the Local Chief Executive to create an Ad Hoc Committee as a negotiating body for the acquisition of land that has a potential source of potable water within the locality;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, the availability of a potable water source is essential for the survival and well-being of the residents for our municipality;





WHEREAS, the acquisition of the land for the purpose of securing the potable water source is crucial for the long-term sustainability and the acquisition process for the land may require negotiation with the landowner;

WHEREAS, the Ad Hoc Committee shall have the authority to negotiate with the landowner regarding the acquisition of the land and to make recommendations to the Municipal Council/Sangguniang Bayan Council regarding the terms and conditions of the acquisition;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. HERMES B. CABALES, the body resolved, as it hereby resolves, to respectfully request the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD, to create an Ad Hoc Committee as a negotiating body for the acquisition of land that has a potential source of potable water within the Municipality of Dumalinao, Zamboanga del Sur.
