WHEREAS, the Local Government Unit of Dumalinao identified in its CY 2022 Annual Investment Program (AIP) outputs under the 20% Economic Development Fund Programs/Projects/Activities classified in five (5) major development thrusts, namely: social, economic, institutional, infrastructure, and environmental services;
