RESOLUTION NO. 0175-2021

RESOLUTION ALLOWING THE ZAMBOANGA DEL SUR I ELECTRIC COOPERATIVE, INC. (ZAMSURECO -I) TO CONSTRUCT THE ELECTRIC TRANSMISSION AND/OR DISTRIBUTION LINE ALONG, UPON, UNDER AND ACROSS THE LAND WHERE THE SURVEY OF THE PROPOSED ELECTRIC DISTRIBUTION LINE DESIGNED TO BE CONSTRUCTED FROM PART OF PUROK MANGGA, BARANGAY METOKONG, DUMALINAO, ZAMBOANGA DEL SUR

WHEREAS, presented to this august body for appropriate action, is the request of the Local Chief Executive to allow the Zamboanga del Sur I Electric Cooperative Inc. (ZAMSURECO- I) to construct the electric transmission and/or distribution line along, upon, under and across the land where the survey of the proposed electric distribution line designed to be constructed from part of Purok Mangga, Barangay Metokong, Dumalinao, Zamboanga del Sur;

WHEREAS, the lawful owners of the parcel of land of their free will, already signed the Right of Way Easement (ROW) documents and agrees to convey ZAMSURECO-I to place, construct, operate, maintain, relocate and replace thereon and electric transmission and/or distribution line or system;



WHEREAS, the constituents of the above mentioned purok specifically Purok Mangga, Barangay Metokong, Dumalinao, Zamboanga del Sur urgently needs an electric service to electrify their respective households;

WHEREAS, this august body acknowledge its responsibility to secure permits from various government agencies to facilitate completion of the Electrification Project of the government;

WHEREAS, if some problems will occur during the implementation of the said electric transmission or distribution lines the Local Government Unit of Dumalinao, Zamboanga del Sur is willing to resolve said problems to pursue the electrification project, which have been the dreams of the people of the community;

NOW, THEREFORE, premises above-considered, on motion by **HON. ELYNOR S. CORTEZ** the body resolved, as it hereby resolves to allow the Zamboanga del Sur I Electric Cooperative Inc. (ZAMSURECO- I) to construct the electric transmission and/or distribution line along, upon, under and across the land where the survey of the proposed electric distribution line designed to be constructed from part of Purok Mangga, Barangay Metokong, Dumalinao, Zamboanga del Sur.
