## **RESOLUTION NO. 0177-2023**

REQUIRING THE OFFICE OF THE SANGGUNIANG KABATAAN PER BARANGAY OF THIS MUNICIPALITY TO CONTRIBUTE THREE THOUSAND PESOS (PHP3, 000.00) FOR THE CELEBRATION OF THE 67TH ARAW NG DUMALINAO.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Jezeil R. Dagupan, to require the Office of the Sangguniang Kabataan per barangay in this Municipality to contribute Three Thousand Pesos (Php3, 000.00) for the celebration of the 67th Araw ng Dumalinao;
