ADOPTING THE IMPLEMENTING GUIDELINES OF THE UNIVERSAL HEALTH CARE PRIMARY CARE BENEFIT I (PCB1) PACKAGE UNDER REPUBLIC ACT NO. 11223 IN THE LOCAL GOVERNMENT UNIT OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the request of the Municipal Health Officer to adopt the Implementing Guidelines of the Universal Health Care Primary Care Benefit I (PCB1) Package under Republic Act No. 11223 in the Local Government Unit of Dumalinao, Zamboanga del Sur;

WHEREAS, under Republic Act No. 11223 or the Universal Health Care Act was signed into law on February 20, 2019, with the aim of providing all Filipinos access to affordable and quality health care services;

WHEREAS, the implementation of the Universal Health Care Act requires the adoption of implementing guidelines by local government units to ensure that the benefits provided by the law are properly and efficiently delivered to its constituents;





WHEREAS, the Local Government Unit of Dumalinao, Zamboanga del Sur recognizes the importance of ensuring that all its residents have access to affordable and quality health care services, and thus commits to the implementation of the Universal Health Care Act;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;
