REQUESTING THE OFFICE OF THE MUNICIPAL ASSESSOR, ENGINEERING AND PLANNING AND DEVELOPMENT COORDINATOR OFFICE OF THE LOCAL GOVERNMENT UNIT OF DUMALINAO TO REPAIR AND/OR CONDUCT CLEARING OPERATIONS OF THE MUNICIPAL ALLEYS AND ROADS IN THE LOCALITY.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Hermes B. Cabales to request the Office of the Municipal Assessor, Engineering and Planning and Development Coordinator Office to repair and/or conduct clearing operations of the municipal alleys and roads in the locality;

WHEREAS, the municipality of Dumalinao is a bustling community with a growing population and economy;
