RESOLUTION NO. 0180-2023

APPROVING THE AUGMENTATION OF FUNDS UNDER CAPITAL OUTLAY OF THE MUNICIPAL ENVIRONMENT AND NATURAL RESOURCES OFFICE (MENRO) AMOUNTING TO ONE HUNDRED THOUSAND PESOS (PHP100, 000.00) TO BE USED FOR AS REVOLVING FUND FOR THE PAVING BLOCKS PRODUCTION AMOUNTING TO FIFTY THOUSAND PESOS (PHP50, 000.00) AND VERMICAST PRODUCTION IN THE SUM OF FIFTY THOUSAND PESOS (PHP50, 000.00) OF THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the request of the Municipal Environment and Natural Resources Officer to approve the augmentation of fund under Capital Outlay of their office amounting to One Hundred Thousand Pesos (Php100, 000.00) to be used for as revolving fund for the paving blocks production amounting to Fifty Thousand Pesos (Php50, 000.00) and vermicast production in the sum of Fifty Thousand Pesos (Php50, 000.00) of the locality;

WHEREAS, the Municipal Environment and Natural Resources Office is in need of source of funds for the production of paving blocks and vermicast;





WHEREAS, there is an available fund under the said office essentially necessary as an indicator as the source of fund;

WHEREAS, the Municipal Budget Officer had certified that as per book of accounts of the said office, the item was found out unutilized and available as of date and can be a source of augmentation;

WHEREAS, that the said amount shall be considered as revolving fund and shall be used solely for the purpose of paving blocks and vermicast production;

WHEREAS, the said production projects will greatly benefit the municipality and its constituents:

NOW, THEREFORE, premises above-considered, on motion by HON. ROMEO G.
