#### **RESOLUTION NO. 0184-2023**

AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLOR S. CERILLES, RMT, MAGD, AND THE MUNICIPAL TREASURER, MR. GUALBERTO U. GEMINA, JR., TO OPEN A SPECIAL BANK ACCOUNT IN THE LAND BANK OF THE PHILIPPINES, PAGADIAN BRANCH, UNDER THE ACCOUNT NAME OF DUMALINAO DISASTER RISK REDUCTION AND MANAGEMENT ALLIANCE OF THE LOCAL GOVERNMENT UNIT OF DUMALINAO, ZAMBOANGA DEL SUR FOR THE OPERATION THEREOF.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Romeo D. Parila to authorize the Local Chief Executive and the Municipal Treasurer to open a special bank account in the LBP-Pagadian Branch, under the account name of Dumalinao Disaster Risk Reduction and Management Alliance of the Local Government Unit of Dumalinao for the operation thereof;

WHEREAS, Section 444 (b), (1), (vi), Article I, Chapter III of R.A 7160 otherwise known as the Local Government Code of 1991, provides that for efficient, effective and economical governance the purpose of which is the general welfare of the



municipality and its inhabitant, the municipal mayor, upon the authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contract, and obligations and such other documents made pursuant to law or ordinance;

WHEREAS, Section 470 (d), (2), Article II of the same Code, states that the treasurer shall take charge of the treasury office, perform the duties provided for under Book II of this Code, and shall take custody and exercise proper management of the funds of the local government unit concerned;

WHEREAS, the establishment of a dedicated bank account will facilitate the efficient and transparent management of funds allocated for disaster risk reduction and management initiatives in the said alliance;

WHEREAS, the Dumalinao DRRM-Alliance, composed of various BLGUs of Dumalinao, that has been established to coordinate and implement programs, projects, and activities related to disaster risk reduction and management;

WHEREAS, it is necessary to authorize the Local Chief Executive and the Municipal Treasurer to open a special bank account in the LBP-Pagadian Branch under the account name of Dumalinao Disaster Risk Reduction and Management Alliance of the Local Government Unit of Dumalinao for the operation thereof;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. ROMEO D. PARILA, the body resolved, as it hereby resolves to authorize the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD, and the Municipal Treasurer, Mr. Gualberto U. Gemina, Jr., to open a special bank account in the Land Bank of the Philippines, Pagadian Branch, under the account name of Dumalinao Disaster Risk Reduction and Management Alliance of the Local Government Unit of Dumalinao, Zamboanga del Sur for the operation thereof.
