#### **RESOLUTION NO. 0188-2021**

RESOLUTION DECLARING VALID AND OPERATIVE THE ANNUAL BUDGET OF BARANGAY MECOLONG, DUMALINAO, ZAMBOANGA DEL SUR FOR FISCAL YEAR 2021 AMOUNTING TO TWO MILLION FOUR HUNDRED FIFTY EIGHT THOUSAND SIX HUNDRED FORTY PESOS (Php2, 458, 640.00)

WHEREAS, presented to this august body for appropriate action, the Barangay Annual Budget of Mecolong, Dumalinao, Zamboanga del Sur for CY 2021 with approved Appropriation Ordinance No. 01-2021, subject to all accounting and auditing rules and procedures;

LIGAN the body resolved, as it hereby resolves to declare valid and operative the Annual Budget for Fiscal Year 2021 of Barangay Mecolong, Dumalinao, Zamboanga del Sur in the amount of Two Million Four Hundred Fifty Eight Thousand Six Hundred Forty Pesos (Php2, 458, 640.00).
