RESPECTFULLY REQUESTING THE HONORABLE MAYOR JUNAFLOR S. CERILLES, RMT, MAGD, TO ALLOCATE FUNDS FOR THE PROPOSED INSTALLATION OF TEN (10) ELECTRICAL LINE POSTS AT PUROK NANGKA, BARANGAY MALASIK, DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Frederick R. Balandra to request the Local Chief Executive to allocate funds for the proposed installation of Ten (10) electrical line posts at Purok Nangka, Barangay Malasik, this municipality;

WHEREAS, Purok Nangka in Barangay Malasik is a densely populated area with a significant number of households that currently lack access to reliable electricity;

WHEREAS, the absence of electricity in Purok Nangka hampers the residents' daily activities and adversely affects their quality of life, education, and economic opportunities;

WHEREAS, the installation of electrical line posts in Purok Nangka will provide a sustainable solution to the prevailing electricity shortage, enabling the residents to enjoy the benefits of reliable power supply;





WHEREAS, the august body recognizes the importance of providing essential services to its constituents and is committed to improve their living conditions;

WHEREAS, the allocation of funds from the Local Chief Executive is necessary to support the proposed installation of ten (10) electrical line posts in Purok Nangka, Barangay Malasik;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. FREDERICK R. BALANDRA, the body resolved, as it hereby resolves to respectfully request the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD, to allocate funds for the proposed installation of Ten (10) electrical line posts at Purok Nangka, Barangay Malasik, Dumalinao, Zamboanga del Sur.
