**RESOLUTION DECLARING VALID AND OPERATIVE THE ANNUAL BUDGET OF BARANGAY ANONANG, DUMALINAO, ZAMBOANGA DEL SUR FOR FISCAL YEAR 2021 AMOUNTING TO TWO MILLION TWO HUNDRED SEVENTY FOUR THOUSAND ONE HUNDRED NINETY PESOS (Php2, 274, 190.00)**

**WHEREAS**, presented to this august body for appropriate action, the Barangay Annual Budget of Barangay Anonang, Dumalinao, Zamboanga del Sur for CY 2021 with approved Appropriation Bill No. 01 series 2020, subject to all accounting and auditing rules and procedures;

LIGAN** the body resolved, as it hereby resolves to declare valid and operative the Annual Budget for Fiscal Year 2021 of Barangay Anonang, Dumalinao, Zamboanga del Sur in the amount of Two Million Two Hundred Seventy Four Thousand One Hundred Ninety Pesos (Php2, 274, 190.00).


