RESOLUTION NO. 0194-2021

RESOLUTION DECLARING VALID AND OPERATIVE THE ANNUAL BUDGET OF BARANGAY LOCUBAN, DUMALINAO, ZAMBOANGA DEL SUR FOR FISCAL YEAR 2021 AMOUNTING TO TWO MILLION TWO HUNDRED SEVENTY SEVEN THOUSAND SEVEN HUNDRED SEVENTY ONE PESOS (Php2, 277, 771.00)

WHEREAS, presented to this august body for appropriate action, the Barangay Annual Budget of Locuban, Dumalinao, Zamboanga del Sur for CY 2021 with approved Appropriation Bill No. 01, subject to all accounting and auditing rules and procedures;

WHEREAS, items appropriated under Appropriation Bill No. 01 of Barangay Locuban is hereby considered operative in its entirety;


WHEREAS, after careful review and exhausted deliberation, finding the same sound, proper, and in order;
