ARCHIE G. ABUHON FOR THE LIVE PERFORMANCE SERVICES AS AN ARTIST, HOST, SINGER, AND JUDGE DURING THE MISS DUMALINAO 2023 PAGEANT NIGHT OF THE 67TH ARAW NG DUMALINAO.

WHEREAS, presented for consideration and appropriate action is the request of the Local Chief Executive, to authorize her to enter into and sign a Contract of Services on behalf of the LGU-Dumalingo with Mr. Archie G. Abuhon for the live performance services during the Miss Dumalinao 2023 pageant night of the 67th Araw ng Dumalinao;

WHEREAS, Section 22 (c) of R.A 7160, otherwise known as the Local Government Code of 1991, provides, that every local government unit, as a corporation, shall, unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned;

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444 (b) (1) (vi) thereof, which provides that upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, obligations, and such other documents made pursuant to law or ordinance:

WHEREAS, the Miss Dumalinao Pageant Night is a significant event during the celebration of the 67th Araw ng Dumalinao, showcasing the talent, beauty, and intelligence of the contestants;

WHEREAS, Mr. Archie Abuhon is a renowned artist, host, singer, and judge known for his exceptional talent and experience in the entertainment industry;

WHEREAS, it is in the best interest of the Municipality of Dumalinao to ensure a memorable and successful Miss Dumalinao 2023 Pageant Night by engaging the services of Mr. Archie Abuhon;

WHEREAS, it is necessary to authorize the Mayor to enter into a contract of service with Mr. Archie Abuhon, outlining the terms and conditions of his talent and performance, to ensure a successful and memorable event;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order,

NOW, THEREFORE, premises above-considered, on motion by HON. MA. GEMMA C. ALBISO, the body resolved, as it hereby resolves to authorize the Local Chief Executive, Honorable Mayor Junaflor S. # **CONTRACT OF SERVICES**

## KNOW ALL MEN BY THESE PRESENTS:

This Contract of Services, made and entered into by and between Municipality of Dumalinao, Zamboanga del Sur, represented in this act by the Municipal Mayor, JUNAFLOR S. CERILLES, RMT, MAGD with office and postal address at Municipal Hall Building, Pag-asa, Dumalinao, Zamboanga del Sur, Philippines, hereinafter referred to as the FIRST PARTY;

#### -and-

MR. ARCHIE G. ABUHON, of legal age, Filipino, of legal age, single and a resident of Unit 509, Bldg. H, One Oasis Condominium, Pasig City, Metro Manila, referred to as the SECOND PARTY:

### -WITNESSETH-

**THAT** the FIRST PARTY, is in dire need of an Artist Producer that will provide Live Pertormance Engagements of Artists to Host, Serenade and Judge during the Miss Dumalinao 2023 Pageant Night as part of the 67th Founding Anniversary of Dumalinao on June 14, 2023;

**THAT** the SECOND PARTY has signified his intention to provide the services needed by the FIRST PARTY;

**THAT** the SECOND PARTY has not been subject of any administrative case nor been previously dismissed from the service due to the commission of an administrative offense;

**THAT** the SECOND PARTY is not related to, nor has any relationship in any degree prohibited under the rules of nepotism, with the FIRST PARTY:

**NOW, THEREFORE**, the FIRST PARTY hereby contracts to hire the services of the SECOND PARTY and the latter agrees thereto with the obligations of the parties specified herein below under the following terms and conditions:

# **OBLIGATIONS OF THE FIRST PARTY:**

(To include other specific duties and responsibilities of the First Party)

 To provide the SECOND PARTY service van with a driver that can be used by the producer and artists to transport from airport to accommodation, accommodation to venue, accommodation to airport.

- 2. To provide the SECOND PARTY sufficient parking for their service van within a reasonably convenient distance to venue.
- 3. To pay the SECOND PARTY the total amount of One Hundred Fifty Thirty Five Pesos (Php 135,000.00) only subject to tax, for the entertainment service package, including their meals, hotel accommodation, and air fare back and forth.
- 4. A 50% deposit of Fee is due upon confirmation of booking. This is a required condition of the SECOND PARTY for the contract to proceed; if a 50% deposit of Fee is not tendered upon said date, no furtherobligation for either party comes due. The remaining 50% of Fee is due immediately after the Show, but may be made earlier.

## **OBLIGATIONS OF THE SECOND PARTY:**

- To provide the FIRST PARTY guest performances of Mr. John Michael Suelo as event host, Mr. Ruslan Kulikov and Mr. Jhasper Manalang as event judges and to serenade the candidates with 1 song each of them on June 14, 2023 during the Miss Dumalinao 2023 Pageant Night which will start at 7:00 Pm at Dumalinao Municipal Gymnasium.
- 2. To provide the FIRST PARTY invitation video for social media posting in the LGU's official Facebook account;
- 3. To post in their individual official Facebook and Instagram accounts announcement materials for their performance;
- 4. To arrive, at most, half an hour before the expected performance.

This contract shall be effective on June 14, 2023.
