RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE HONORABLE JUNAFLORES S. CERILLES TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN ENVIRONMENTAL MANAGEMENT BUREAU-REGION IX REPRESENTED BY ITS REGIONAL DIRECTOR ENGR. ALEX D. JIMENEZ, AS THE RECIPIENT/BENEFICIARY OF A SET OF ECOLOGICAL SOLID WASTE MANAGEMENT EQUIPMENT CONSISTING OF BIODEGRADABLE WASTE SHREDDER, ROTARY DRUM COMPOSTER, AND SOLAR POWERED 4G CAMERA KIT FOR THE IMPLEMENTATION OF SOLID WASTE MANAGEMENT PROGRAM IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR

WHEREAS, presented to this august body for appropriate action, is the request of the Local Chief Executive to authorize her, to enter into a Memorandum of Agreement (MOA) by and between Environmental Management Bureau-Region IX, represented by its Regional Director Engr. Alex D. Jimenez, as the recipient/beneficiary of a set of Ecological Solid Waste Management Equipment consisting of Biodegradable Waste Shredder, Rotary Drum Composter, and Solar Powered 4G Camera Kit for the implementation of solid waste management program in the Municipality of Dumalinao, Zamboanga del Sur;



WHEREAS, pursuant to Section 8 of R.A 9003 otherwise known as the Ecological Solid Waste Management Act of 2002 provides that the Environmental Management Bureau shall provide technical and other capability building assistance and support to the LGUs in the development and implementation of local solid waste management plans and programs;

WHEREAS, the local government unit is mandated to provide basic services and facilities which help to reduce the universal problem in waste disposal through solid waste disposal system or environmental management system;

WHEREAS, the LGU-Dumalinao is qualified as a recipient of a set of Ecological Solid Waste Management Equipment consisting of Biodegradable Waste Shredder, Rotary Drum Composter, and Solar Powered 4G Camera Kit in order to implement the solid wastes management project;

WHEREAS, after finding the same to be of great importance and help, this august body finds it necessary to authorize the Local Chief Executive in order to implement the aforesaid project in the locality;
