RESOLUTION NO. 0196-2023

AUTHORIZING THE LOCAL CHIEF EXECUTIVE HONORABLE MAYOR JUNAFLO R. CERILLES, RMT, MAGD, TO ENTER INTO AND SIGN A CONTRACT OF SERVICES ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF DUMALINAO WITH MR. JONAS B. LASCO FOR THE ENGAGEMENT OF SERVICES AS PAGEANT/EVENT ORGANIZER FOR MISS DUMALINAO 2023 DURING THE 67TH FOUNDING ANNIVERSARY OF DUMALINAO.

WHEREAS, presented for consideration and appropriate action is the request of the Local Chief Executive, to authorize her to enter into and sign a Contract of Services on behalf of the LGU-Dumalinao with Mr. Jonas B. Lasco for the engagement of services as pageant/event organizer for Miss Dumalinao 2023 during the 67th Araw ng Dumalinao;

WHEREAS, Section 22 (c) of R.A 7160, otherwise known as the Local Government Code of 1991, provides, that every local government unit, as a corporation, shall, unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned;



WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444 (b) (1) (vi) thereof, which provides that upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, the Municipality of Dumalinao has a long-standing tradition of celebrating the Araw ng Dumalinao, an annual festival that commemorates the rich cultural heritage and achievements of our community;

WHEREAS, organizing a successful pageant as part of the Araw ng Dumalinao requires professional expertise, meticulous planning, and effective management to ensure a memorable and engaging experience for participants and spectators alike;

WHEREAS, Mr. Jonas Lasco, an experienced and reputable pageant/event organizer with a proven track record, has expressed interest in providing his services as the pageant/event organizer for Miss Dumalinao 2023 during the 67th Araw ng Dumalinao;

WHEREAS, it is essential to secure the services of Mr. Jonas Lasco through a formal contract to ensure a clear understanding of the scope of work, responsibilities, and compensation for his services;;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. ROMEO D. PARILA**, the body resolved, as it hereby resolves to authorize the Local Chief Executive, Honorable Mayor Junafior S. Cerilles, RMT, MAGD, to enter into and sign a Contract of Services on behalf of the Local Government Unit of Dumalinao with with Mr. Jonas B. Lasco for the engagement of services as pageant/event organizer for Miss Dumalinao 2023 during the 67th Araw ng Dumalinao.

CONTRACT OF SERVICES

KNOW ALL MEN BY THESE PRESENTS:

This Contract of Services, made and entered into by and between **Municipality of Dumalinao, Zamboanga del Sur**, represented in this act by the Municipal Mayor, **JUNAFLO S. CERILLES, RMT, MAGD** with office and postal address at Municipal Hall Building, Pag-asa, Dumalinao, Zamboanga del Sur, Philippines, hereinafter referred to as the **FIRST PARTY**;

-and-

MR. JONAS B. LASCO, of legal age, Filipino, of legal age, single and a resident of San Jose, Pagadian City, Zamboanga del Sur, Philippines to as the **SECOND PARTY**;

-WITNESSETH-

THAT the FIRST PARTY, is in dire need of a Pageant / Event Organizer for Miss Dumalinao 2023 as part of the 67th Founding Anniversary of Dumalinao on June 14, 2023 ;

THAT the SECOND PARTY has signified his intention to provide the services needed by the FIRST PARTY;

THAT the SECOND PARTY has not been subject of any administrative case nor been previously dismissed from the service due to the commission of an administrative offense;

THAT the SECOND PARTY is not related to, nor has any relationship in any degree prohibited under the rules of nepotism, with the FIRST PARTY;

NOW, THEREFORE, the FIRST PARTY hereby contracts to hire the services of the SECOND PARTY and the latter agrees thereto with the obligations of the parties specified herein below under the following terms and conditions:

OBLIGATIONS OF THE FIRST PARTY:

(To include other specific duties and responsibilities of the First Party)

1. To provide the SECOND PARTY meals and snacks during pre-pageant activities such as the photoshoot of candidates and practices;
2. To pay the SECOND PARTY the total amount of Sixty Seven Thousand Five Hundred Pesos (Php 67,500.00) only subject to tax, for the service package after the event on June 14, 2023.

OBLIGATIONS OF THE SECOND PARTY:

- 1. To provide the FIRST PARTY an organized pageant for Miss Dumalinao 2023 from Candidate's Screening, Orientation, Photoshoot, Practices, and Pageant Night proper;

This contract shall be effective on June 14, 2023.
