CERILLES, DUMALINAO, ZAMBOANGA DEL SUR, TO ENTER INTO A CONTRACT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD-IX) FOR THE IMPLEMENTATION OF THE ADDITIONAL FINANCING FOR THE KALAHI-CIDSS: NCDDP UNDER WORLD BANK FUNDING FOR CY 2021 IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.**
