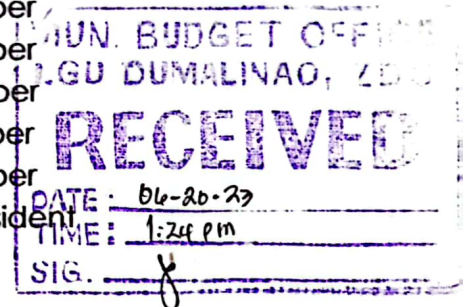

**EARNESTLY REQUESTING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLOR S. CERILLES, RMT, MAGD, TO ALLOCATE FUNDS FOR THE TRAVEL ALLOWANCES OF THE PRESIDENT OF MUNICIPAL FISHERIES AND AQUATIC RESOURCE MANAGEMENT COUNCIL AND PRESIDENT OF THE MUNICIPAL AGRICULTURAL AND FISHERIES COUNCIL IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.**

**WHEREAS,** presented for consideration and appropriate action is the proposed resolution of Hon. Romeo D. Parila to earnestly request the Local Chief Executive to allocate funds for the travel allowances of the president of Municipal Fisheries and Aquatic Resource Management Council and president of the Municipal Agricultural and Fisheries Council in the locality;
