TO ENTER INTO A CONTRACT OF AGREEMENT BY AND BETWEEN DUMALINAO SMALL COCONUT FARMERS ORGANIZATION FOR THE IMPLEMENTATION OF LIVELIHOOD PROGRAM OF THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented to this august body for appropriate action, is the request of the Local Chief Executive to authorize her to enter into a contract of agreement by and between Dumalinao Small Coconut Farmers Organization for the implementation of livelihood program of the Municipality of Dumalinao, Zamboanga del Sur;
