AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLOR S. CERILLES, RMT, MAGD, TO PURCHASE AND SIGN THE DEED OF SALE ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF DUMALINAO BY AND BETWEEN MS. GISELLE CELERIAN AND MS. GLADYS LAVILLA COVERED WITH A TRANSFER CERTIFICATE OF TITLE NO. E-17. 840. WITH A TOTAL LAND AREA OF THIRTY-FOUR THOUSAND SEVEN HUNDRED SIXTY-TWO SQUARE METERS (34, 762 SQ), LOCATED AT BARANGAY ANONANG FOR THE DEVELOPMENT OF DUMALINAO CEMETERY AND EVACUATION AREA OF THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the request of the Local Chief Executive to authorize her to purchase and sign the Deed of Sale on behalf of the LGU-Dumalinao by and between Ms. Giselle Celerian and Gladys Lavilla covered with a TCT No. E-17, 840 with the total area of 34, 762 square meters, located at Barangay Anonang for the development of Dumalinao Cemetery and Evacuation Area of the locality;

WHEREAS, Section 22 of R.A 7160, otherwise known as the Local Government Code of 1991, provides that the local government units shall have the power and



authority to acquire, develop, lease, encumber, alienate, or otherwise dispose of real or personal property held by them in their proprietary capacity;

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444 (b) (1) (vi) thereof, which provides that upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, the Local Government Unit of Dumalinao envisions the development of the Dumalinao Memorial Garden and Evacuation Area to serve the growing needs of the community;

WHEREAS, Ms. Giselle Celerian and Ms. Gladys Lavilla are willing to sell a parcel of land covered by Transfer Certificate of Title No. E-17, 840 with a total land area of Thirty-Four Thousand Seven Hundred Sixty-Two Square Meters (34, 762 SQ) situated at Barangay Anonang, Dumalinao, Zamboanga del Sur, for the said development;

WHEREAS, under Resolution No. 12 Series of 2023 of the Provincial Appraisal Committee (PAC), recommended, as reasonable valuation and most advantageous to the municipality, the amount of Four Million Thirty-Two Thousand Three Hundred Ninety-Two Pesos (Php4, 032, 392.00) as the basis to purchase the 34, 762 square meter portion of Lot 6574-B, CSD-5717, situated at Barangay Anonang;

WHEREAS, the LGU-Dumalinao, through the Municipal Development Council (MDC), allocated a budget for the acquisition of the said parcel of land under the MDC Resolution No. 3 Series of 2023 and at the same time, is currently available, as certified by the Municipal Budget Officer of the locality;

WHEREAS, the acquisition of the said property is crucial to implement the local government's plans for the welfare and benefit of its constituents;

WHEREAS, after careful review and exhausted deliberation, finding the same sound, proper, and in order;

NOW, THEREFORE, premises above-considered, on motion by HON. ROMEO G. LIGAN, the body resolved, as it hereby resolves to authorize the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD, to purchase and sign the Deed of Sale on behalf of the Local Government Unit of Dumalinao by and between Ms. Giselle Celerian and Ms. Gladys Lavilla covered with a Transfer Certificate of Title No. E-17, 840, with a total land area of Thirty-Four Thousand Seven Hundred Sixty-Two square meters (34, 762 SQ), located at Barangay Anonang for the development of Dumalinao Cemetery and Evacuation Area of the Municipality of Dumalinao, Zamboanga del Sur.



"A RESOLUTION RECOMMENDING THE AMOUNT OF PHP4,032,392.00 AS THE FAIR MARKET VALUE TO PURCHASE THE 34,762 SQUARE METER PORTION OF LOT 5674-B, CSD-5717 LOCATED AT BARANGAY ANONANG, DUMALINAO, ZAMBOANGA DEL SUR TO BE UTILIZED AS ACCESS ROAD FOR THE PROPOSED CEMETERY PROJECT OF THE MLGU OF DUMALINAO"

WHEREAS, presented for the consideration is the Appraisal Report submitted by the PAC-TWG of the **34,762 sq. m.** portion of **Lot 5674-B, CSD-5717** located at Barangay Anonang, Dumalinao, to be purchased by the MLGU of Dumalinao for the access road of the proposed cemetery project;

WHEREAS, the 34,762 sq. m is a of portion of Lot 5674-B, CSD-5717 with ARP No. 16-05-0003-00293, declared in the name of Giselle Celerian and Gladys Lavilla located at Barangay Anonang, Dumalinao, Zamboanga del Sur;

WHEREAS, an offer to sell was issued by the property owners Giselle Celerian and Gladys Lavilla offering to sell the property portion of Lot 5674-B, CSD-5717 with an area of 34,762 square meter in the amount of Php122.00/ sq.m;

WHEREAS, a certification issued by the Municipal Budget Officer Ms. Dinah L. Saldua-Fuentes, CPA states that an amount of Four Million Two Hundred Thousand Pesos (Php4,200,000.00) is currently available for lot purchase at Anonang, Dumalinao;

WHEREAS, a letter issued by the Municipal Mayor of Dumalinao Hon. Junaflor S. Cerilles, RMT, MAGD dated May 25,2023 requesting the Provincial Appraisal Committee to conduct ocular inspection and appraisal of the lots owned by Giselle Celerian and Gladys Lavilla located at Barangay Anonang, Dumalinao, Zamboanga del Sur;

WHEREAS, this Committee, through the Technical Working Group (TWG), conducted an ocular inspection and investigation on the premises last May 31, 2023 and found that the property is adjacent to the recently purchased cemetery and evacuation site of the MLGU;

WHEREAS, the Provincial Appraisal Committee in determining the valuation of the subject lot, considered the difficult factors that influence the value as exablished by the generally accepted principle in the conduct of appraisal more particularly its highest and best value. The PAC also considered the recent sales data dated last January 2023 which is Php116/sq.m in determining the fair market value of the property;

NOW, THEREFORE, all premises considered, the Committee, assembled en banc has;

RESOLVED, as it is hereby resolved, to recommend using the amount of **Php4,032,392.00** as the basis to purchase the **34,762 square meter** portion of Lot 5674-B, CSD-5717, situated at Barangay Anonang, Dumalinao, Zamboanga del Sur, such valuation being reasonable and most advantageous to the MLGU of Dumalinao, Zamboanga del Sur;

RESOLVED FINALLY, to furnish copy of this resolution to the requesting party and the concerned Municipal Assessor for their information and reference.
