CERILLES, OF DUMALINAO, ZAMBOANGA DEL SUR, TO ENTER INTO A MEMORANDUM OF AGREEMENT BY AND BETWEEN DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD-IX) REPRESENTED BY ITS OIC REGIONAL DIRECTOR ATTY. SITIE RAIFAH M. PAMALOY-HASSAN FOR THE SUPPLEMENTARY FEEDING PROGRAM FOR THE 11<sup>th</sup> CYCLE IMPLEMENTATION OF THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR**

**WHEREAS**, presented to this august body for appropriate action, is the request of the Local Chief Executive to authorize her to enter into a Memorandum of Agreement by and between Department of Social Welfare and Development (DSWD-IX) represented by its OIC Regional Director Atty. Sittie Raifah M. Pamaloy-Hassan for the Supplementary Feeding Program for the 11<sup>th</sup> Cycle implementation of the Municipality of Dumalinao, Zamboanga del Sur;

**WHEREAS**, pursuant to Memorandum Circular No. 12 Series of 2020, the Supplementary Feeding Program is the provision of food in addition to regular meals to target children ages 3-4 years old enrolled in the Child Development Center (CDCs) and Supervised Neighborhood Play (SNPs) as part of the DSWD's



contribution to the early childhood care and development (ECCD) program of the government;

**WHEREAS**, the Local Government Unit of Dumalinao aims to provide basic services and programs to address the issue of hunger and food security especially in this time of pandemic in the locality;

**WHEREAS**, after careful review and exhausted deliberation, finding the same sound, proper, and in order;
