

RESPECTFULLY REQUESTING THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP) -PAGADIAN CITY BRANCH TO INSTALL ONE (1) UNIT OF AUTOMATED TELLER MACHINE (ATM) IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Hermes B. Cabales to respectfully request the Development Bank of the Philippines (DBP) - Pagadian City Branch to install one (1) unit of Automated Teller Machine (ATM) in the locality;

WHEREAS, the residents and constituents of the municipality have been experiencing challenges in accessing banking services, particularly the withdrawal of funds from their respective accounts;

WHEREAS, the Development Bank of the Philippines (DBP) - Pagadian City Branch has been a trusted and reliable banking institution that has provided essential financial services to the community;

WHEREAS, the absence of an Automated Teller Machine (ATM) within the municipality has posed inconveniences to residents, including the need to travel long distances to access banking facilities in neighboring areas;

WHEREAS, the Municipal Hall Building of Dumalinao is a suitable location within the municipality for the placed of installation of the requested ATM unit, which is an area easily accessible to a majority of the residents;

WHEREAS, the august body finds it necessary the installation of an ATM in the locality will greatly contribute to the convenience and financial inclusion of the residents, enabling them to perform banking transactions closer to their homes;




